RESOLUTION NO. 2014-02

OF THE TRUCKEE TAHOE AIRPORT DISTRICT DEFERRED COMPENSATION PLAN

The Board of Directors of the Truckee Tahoe Airport District resolves as follows:

1. Findings:

- A. The TRUCKEE TAHOE AIRPORT DISTRICT (TTAD) passed Resolution 1988-03 "TTAD Deferred Compensation Plan" on September 20, 1988 which established the Truckee Tahoe Airport District Deferred Compensation Plan ("Plan") for the voluntary participation of all eligible employees and elected officials; and
- B. The Plan established by the Board of Directors in 1988 was aligned with the U.S. Conference of Mayors Deferred Compensation Program ("Program"); and
- C. The U.S. Conference of Mayors selected Great-West Retirement Services ("Administrator") as the new provider of administrative, recordkeeping and education services for the Program in 2012; and
- D. Documents were required to be signed on behalf of the District to establish the Plan with the Administrator, and the Board of Directors authorized the Director of Finance and Administration to act on behalf of the District.

2. Adoption of Deferred Compensation Plan.

- A. TTAD hereby adopts the "Truckee Tahoe Airport District Deferred Compensation Plan," a part of the "United States Conference of Mayors Retirement Program, Section 457(b), Eligible Deferred Compensation Plan for Governmental Employers, Administered by Great-West Retirement Services," retroactively effective December 12, 2012, and directs Great-West Retirement Services to administer the Plan in accordance with the terms.
- B. The Director of Finance and Administration is hereby authorized to execute for the District, individual participation agreements with each said employee requesting same, and to act as the "Administrator" of the Plan, representing the District and to execute such agreements and contracts as are necessary to implement the plan. It is implicitly understood that other than the incidental expenses of collecting and disbursing the employees' deferrals and other minor administrative matters, that there is to be no cost to the District for the plan.
