Discussion	Staff and the Ad Hoc Committee continue to work with the Master Plan consultant Mead & Hunt to finalize the draft Master Plan. The Ad Hoc Committee and staff would like the Board to review these chapters and provide input and comments as they move forward with completing the full draft Master Plan document.
