The Airport Layout Plan (ALP) is a component of the Airport Master Plan. The ALP identifies improvements needed to address any design deficiencies, growth in community and/or aviation demand levels as well as changing conditions and circumstances at the airport. The ALP and the aviation forecasts chapter are the two required components of the Master Plan to be reviewed and approved by the FAA. They are kept on file at the FAA Airport District Office in San Francisco. The Master Plan is an essential and important tool in the Districts ability to secure Federal Airport Improvement Program funding.

Purpose of today's discussion is to review the ALP Plan Set with the Board and public. The ALP has been reviewed in detail by the Master Plan Ad Hoc Committee. Overall, this ALP reduces the overall footprint of the airport as compared to the 2000 ALP.

Staff will also distribute Chapter 5 - Implementation Plan to the Board and interested members of the public. The Implementation plan will be reviewed in more detail at the May 28, 2014 Board Meeting.

Master Plan Final Timeline

- April 23, 2014 Board review of ALP plan set and distribution of Chapter 5 - Implementation Plan
- May 9, 2014 complete draft of Master Plan with ALP set and appendix will be delivered to the board and posted on the master plan website.
- May 28, 2014 Mead & Hunt will present the final draft of the Master Plan for Board review and approval.
- June 4, 2014 to July 9, 2014 Master Plan public comment period.
- **July 23, 2014** Board will review public comments and amend master plan accordingly.
- August 27, 2014 final approval of Master Plan and commencement of California Environmental Quality Act submission. Staff anticipates six months to complete CEQA

Communication Strategy	Staff will continue to post new information on the Master Plan website. Staff is also working with Fresh Tracks Communications to formulate a formal outreach campaign to notify the public when the full draft Master Plan is available for public comment and
