May 29, 2014

Subject: 3.3 and 4.3 plus a few other comments

Message Body:

1. More public outreach to encourage reporting below minimum flight altitudes over residential area with use of frequent property owner mailings to encourage same.

2. Educate homeowners on how to estimate over head flight altitudes for more accurate reporting.

3. Stronger messages to instructors and students regarding keeping touch and go training over open space and nonresidential area or at least to vary patterns so repeat flyovers are varied. Perhaps consider rental subsidy to offset longer airtime if appropriate to encourage same.

4. More Truckee aviation history exhibits permanent and rotating

5. When an annoying over flight is reported by a public person some email follow up with reporting person regarding the specific incident. This would also educate the reporting person as to the validity and accuracy of his or her specific report. A phone call follow up from airport staff asking simply if annoyances are greater or fewer may be valuable to airport but not very helpful to a public reporter, and does not give reporting person and confidence that their report was actually reviewed and some attempt to resolve was completed.

6. Keep buying more open space. A great use of taxpayer money.

5.) Your overall plan is very good, but remember, tourism is your priority! Most people who live there were allowed to come there. They DO NOT

have the right to tell us we can't come up and visit. We spend money there, without us the airport and business's would greatly suffer. We will respect the noise abatement procedures and things like that, that's only respectful. Down here at the Santa Rosa airport, they have finally gotten off their ass's and expanded the runway's, improved the overall airport plan, and remodeled the terminal. I was part of that process that took many, many years. But, they finally had to realize that tourism is a huge part in Napa and Sonoma County, and that if they were going to build on this new economic venture, they had better quit catering to the minority naysayers and move forward for the good of everyone, jobs, and business's. This new venture here will bring in the Regional Jets from much further distances out. You don't need to do that, but you do need to continue making the necessary improvements such as I have outlined above.

Subject: noise pollution

Message Body:

I've become frustrated to the point of no longer bothering to contact the airport about the noise from jets flying overhead. Every time I do call I get a polite person who expresses understanding, and nothing changes. I believe there are many others in the same situation, so don't make the mistake of assuming that, just because you don't hear from people, they're not fed up. I don't know where the district gets the idea that



residents in general are happy with the way things are being run at the airport. If you went around to the various neighborhoods affected by airport noise I think you would get a very different picture.

While prop planes are much less intrusive than jets, the latter seem to be increasing at an alarming rate, and are clearly at odds with the natural setting where we live. I can't think of any other situation in which so many people are adversely affected for the mere convenience of so few. And now the district wants to use public money to build a hangar to cater to corporate jets? That is beyond insulting to the residents of the area.

At this point, thanks to the impact of jets and the lack of anything significant being done to address the problems they cause, were it to come to a vote I would vote to close the airport down, or at least to restrict it to just prop planes. Certainly at this point I have no interest in seeing public money going to support the use of jets at the airport. I see nothing in the master plan that sufficiently addresses this issue. Until I do I will continue to feel the same way, and I can almost guarantee that many others hold similar feelings on the subject.

Subject: Low flying aircraft/Increased noise

Message Body: Mr. Smith,

I am writing because in the last few months I have noticed quite a bit more air traffic, low flying planes, and increased noise over my home. I understand that with the proposed master plan that flight paths are being changed and I'm concerned about the impact on the enjoyment of our home and yard. July 9, 2014 Subject: Air Traffic Control / Chapter 4

Message Body:

The document suggests that a permanent air traffic control tower may be built and staffed during summer months. Several countries are now using remote control (virtual towers) for small airports. This is much less expensive than building and maintaining a physical tower and hiring contract tower operators. If an ATC physical tower is to be considered, within the next several years, the remote virtual tower concept should also be considered. By then the technology will be well developed.

Dear Kevin:

Thank you for the opportunity to comment on the Truckee Tahoe Airport District (TTAD) Draft Master Plan (DMP). While reviewing the DMP, our attention was drawn to Section 4.1, Development Suitability by Location, beginning on page 4-38.

As to Block D (Upper north side), it is noted that "...acquisition of land north of the approach end of Runway 11 would bridge existing airport property to Joerger Drive, provide road access and increase the potential for aviation related use." Block E (North Bluff) is described as a strip of land with no practical development use. Block F (Lower north side) was characterized as an area wherein, "Aviation-related usage would be impractical. Nonaviation use is a possibility, but limited road accessibility and lack of utilities are significant impediments to most such use."

As you and I have discussed previously, Tahoe-Truckee Sanitation Agency (T-TSA) has expressed an interest over a period of several decades in entering into negotiations with the TTAD to exchange certain portions of land currently owned by T-TSA and TTAD. Of particular interest to T-TSA has been the acquisition of the TTAD property known as Nevada County APN 49-040-11 (Biock F). T-TSA has acquired significant acreage surrounding its facilities in an attempt to minimize negative impacts to its operations—including its treatment facilities, underground effluent disposal field, and groundwater monitoring wells—as well as to minimize T-TSA's impacts on others. T-TSA also is concerned about the water quality and quantity of the groundwater supply, Martis Creek and the Truckee River and how any development on Block F could impact traffic on Joerger Drive in such a way as to be incompatible with its existing uses.

T-TSA shares a common approach with TTAD in protecting its current and future operations through efforts to acquire surrounding properties in order to minimize conflicting interests and to act as "buffer zones." In the future, it is possible that T-TSA will have to relocate or expand its subsurface disposal field and/or institute a spray irrigation field to increase its capacity to treat and dispose of effluent—either of which could be impacted by the future uses of the Block F parcel. In the case of spray irrigation fields, which could be described as giant treated wastewater sprinklers, the treated effluent could be

transported by wind to the property in question and have a negative effect on any development on that property. T-TSA also is concerned about the inadvertent release of hazardous chemicals that are transported to, and stored at, the T-TSA facilities, and how that could affect a commercial business should it be located on that property. Historically, the acquisition by T-TSA of property surrounding our facilities has succeeded in minimizing potential negative impacts of our operations on others.

In the past, TTAD has expressed an interest in acquiring portions of T-TSA's property at the end of both TTAD runways and portions of Block E and Block D. T-TSA would like to encourage TTAD to enter into negotiations with T-TSA at this time to either exchange or purchase properties that the other entity holds, which would likely benefit both parties.

Thank you for the opportunity to comment on the draft Airport District 2025 Master Plan. Overall, the Town is excited to see this planning effort heading to the final adoption phase. We believe that the plan reflects the values and desires of our region and will serve as a comprehensive long-range plan for the future of the airport. The Town has been impressed with the commitment to public education and active community involvement in this planning effort. The Truckee community has had ample opportunity to understand and participate in the development of this long range plan for the airport.

The Town is particularly supportive of the efforts to reduce the noise and safety impacts of future air traffic, particularly as compared with the 2000 Master Plan effort. This future Plan coupled with the Airport's aggressive efforts on pilot education and community outreach, will significantly reduce airport related impacts on the Truckee community into the future. We look forward to working collaborative with the District and the Truckee Tahoe Airport Land Use Commission on the upcoming update to the Comprehensive Land Use Plan for the Airport environs.

We look forward to working closely with the District staff and Board of Directors to pursue a "win-win" approach that will result in the best comprehensive planning for the Airport and the greater Truckee
