

RESOLUTION NUMBER **2017-06**
OF THE TRUCKEE TAHOE AIRPORT DISTRICT

TO ACKNOWLEDGE AND APPROVE THE AIRPORT CAPITAL
IMPROVEMENT PROJECTS FOR 2017/2018

WHEREAS, the Truckee Tahoe Airport District and the Federal Aviation Administration annually participate in Federal Airport Improvement Program; and

WHEREAS, the California Department of Transportation, pursuant to the Public Utilities Code section 21683.1, provides grants up to 5% of Federal Aviation Administration grants to airports; and

WHEREAS, the Federal Aviation Administration and the California Department of Transportation encourages and/or requires the Board of Directors to adopt a resolution authorizing the submission of an application for AIP Matching grants as well as authorize signatories;

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Truckee Tahoe Airport District:

1. Authorizes filing an application for Federal and State AIP Matching grant for the following projects:
 - 1) Reconstruct Taxilanes R – Design and Construct;
 - 2) Taxilanes A through C, Hangars L & M and Warehouse Taxilanes – Joint and Crack Repair – Design and Construct;
2. Authorizes accepting the allocation of Federal and State AIP Matching funds for these projects.
3. Authorizes execution of Federal AIP Grants and State AIP Matching Grant Agreements for these projects; and

BE IT FURTHER RESOLVED, that the Board of Directors of the Truckee Tahoe Airport District does hereby authorize KEVIN SMITH, General Manager of the Truckee Tahoe Airport District, to sign any documents required to apply for, accept, and process these subject funds on behalf of the Truckee Tahoe Airport District.
