- 23 PUBLIC COUNT: 4
- 24 SPECIAL ORDERS OF BUSINESS: None
- 25 Mr. Smith informed the Board and ACAT members that the District was successful in collecting and
- 26 submitting passenger enplanement numbers for 2016. The FAA accepted the data and the Airport was
- 27 upgraded to a National Airport. This status will allow the District to receive a higher amount of FAA grant
- 28 funds for projects on its ACIP project list. In order for the District to maintain its National Airport status,
- 29 staff will have to continue to collect and submit passenger entitlement numbers on a yearly basis. This
- 30 changed the District's entitlement from \$150,000/year to \$1,000,000/year. This was a significant
- 31 accomplishment.
- 32 Ms. Jill McClendon, project coordinator for TTAD, reviewed the current Executive hangar waiting list, as
- 33 well as the T-Hanger waiting list.

- 37 There was Board and ACAT member consensus that there was no need to do introductions.

EXISTING ACAT WORK PLAN INTRODUCTIONS & QUESTIONS

- 40 Airport Trails Network (Krueger & Golden)
- 41 Mr. Bullock reviewed the Airport Trails Network project description. The project will be entering its second
- 42 phase of the District Trails Masterplan, which includes partnership building, exploring funding sources,
- 43 grant applications and trail alignments. Potential partners for the trail system were discussed, as well as
- 44 cost estimates of different class ratings of trails. Safety concerns were expressed by Member Fast
- 45 regarding trail users and their interaction with the airfield. Mr. Smith informed the group that the
- 46 proposed trail network around the airport would not be in violation with any existing FAA or TSA security
- 47 rules. There was support for this project from all Board members, and encouragement for ACAT to start
- 48 exploring grant funding options immediately.
- 49 Member Polverari entered meeting at 9:16 AM.
- Mountain Top AWOS (Fast & Golden)
- 51 The Mountain Top AWOS project involves placing a weather observation and reporting station atop a
- 52 mountain peak near the Airport. The system must be certified and supported by the National Weather
- Service and the FAA. Mr. Cooke stated that the Mountain Top AWOS project has been active for the past
- three years, though the project has yet to gain support by the FAA. Mr. Cooke reviewed the reasons
- 55 behind choosing Squaw VOR as the location for the AWOS station. Though, the ultimate reason comes
- down to having the ability for the station to be considered "certified". Discussion ensued regarding the
- 57 difference between a weather observation and a weather forecast. There was support for this project
- from all Board members, and encouragement for District staff to start utilizing the Washington D.C.
- lobbyist to get the project in the hands of the right individuals at the FAA.
 - Pilot Incentives (Polverari & Fast)
- 61 Ms. Katie Greenwood reviewed the two proposed Pilot Incentive programs: Mountain Flying Check-Out
- 62 and the Touch and Go Incentive program. The Mountain Flying Check out is designed to incentivize pilots
- 63 (\$50) to thoroughly understand our noise abatement programs by participating in a 30 minute education
- 64 program with Ms. Greenwood and submitting log book entries indicating that their Mountain Check-out
- 65 flight tracks complies with the District's NAP guidelines. Ms. Greenwood requested the Board's approval
- 66 of this program as she starts her Roadshows in January and would like to promote the program. Discussion
- 67 ensued amongst Board and ACAT members regarding the project and there was consensus that the
- 68 program should be offered to pilots training locally as well as increasing the incentive to \$100 instead of
- 69 \$50.

- 72 ACAT MOTION #1 DEC-12-2017: Member Fast motioned to approve the increase of the incentive fund to
- 5100 per student pilot and the total budget of the Mountain Flying Check-Out program to be \$10,000
- vith an option to increase if need be. Member Polverari seconded the motion. Members Krueger, Golden,
- 75 Polverari, Fast and Rohlf voted in favor of the motion. Motion passed.
- 76 BOARD MOTION #1 DEC-12-2017: President Stephens motioned to approve the increase of the incentive
- 77 fund to \$100 per student pilot and the total budget of the Mountain Flying Check-Out program to be
- 78 \$10,000 with an option to increase if need be. Director Jones seconded the motion. President Stephens,
- 79 and Directors Jones, O'Dette and Morrison voted in favor of the motion. Motion passed.
- The Touch and Go Incentive Program is designed to incentive pilots to avoid flying repetitive touch and go
- 81 operations at the Truckee Tahoe Airport. The program will not indicate which airport the pilots should do
- their Touch and Go's at, but stated the airport must be in a radius of 50 NM of KTRK. This program also
- does not require pilots to fly at alternative airports. Member Krueger stated that this specific program
- had a lot of comments from ACAT member's at the ACAT November meeting. Member Krueger expressed
- 85 ACAT's desire for Board comments on this program. President Stephens stated that he was under the
- 86 impression that this program was backed off from due to the Board's desire to purchase the diesel aircraft
- 87 which will be used for training purposes at KTRK. There was Board consensus for ACAT to continue to fine
- tune this specific project as it is not ready to roll out in its current state.
- 89 Member Golden left meeting at 10:11 AM.
- 90 Pilot Messaging (Fast)
- 91 Mr. Bullock stated that the Pilot Messaging project is designed to unify and standardize all of important
- 92 pilot information related to outreach and annoyance reduction. From kiosks, to signs, print, website, and
- 93 e-blasts this project will take a close look at messaging and unification of design principals, delivery, and
- 94 messaging. Member Fast stated that this project was just adopted in November and more information
- 95 will follow at a later date.

- Non-Aeronautical Land Use (Rohlf & Polverari)
- 97 District Council Collinson disclosed, for the sake of transparency, that he owns offices that is available for
- 98 rent less than a mile away from the Airport. Mr. Smith reviewed the TTSA land swap that is currently in
- 99 negotiation, and the potential rezoning of properties on Soaring Way. Mr. Smith also explained long term
- 100 leasing rules that exist with the FAA. There was consensus to continue with the findings that were
- approved at the November 30th Board meeting.
- 102 Vice President Morrison left meeting at 10:30 AM
- 103 **PUBLIC COMMENT:** None
 - **ADDITIONAL ITEMS FOR ACAT 2018 WORK PLAN:**
- 105 Ms. Greenwood noted the bypass light project as a future potential project. Discussion followed regarding
- the painted arrow at the end of Runway 29. Staff stated that there has not been enough traffic to gauge
- its effectiveness yet. Director Jones expressed his desire for sound insulation and home acquisition to be
- 108 explored. Mr. Smith indicated that home insulation and property acquisition will be discussed at the
- 109 March 2018 Board workshop.
