- Data collected should help drive programs
- Measure repeat pilot offenders
- o Holistic
- Next steps:
 - Staff to create a new tool for measuring success—something like a Scorecard or Dashboard framework that shows the various elements that comprise the noise + annoyance program
 - Tool may be shown to board quarterly rather than monthly to allow for fresh thinking on the data and possible innovative strategies to develop
 - Tool will include current data but will focus on packaging up all of the various components in order to make easier for staff + board to see possible new opportunities or weaknesses.
 - Timeline: Tool needs to be in place prior to first set of data collected with new tower (June draft to Boa

I. Temporary Season Tower: Expectations + Metrics for Success

Staff presented the criteria that would be used to measure success for the tower this summer. The poster below describes the content shared with staff. Safety is in the center as the top priority and all other metrics surrounding safety pertain to noise and annoyance. The Board discussed the materials and agreed that staff was on the right track with the data being collected to measure success. The board will get additional updates at upcoming meetings. The data collected will be incorporated into the new Dashboard Tool described above. Again, this is data already being collected by staff, what is new is the way the information will be presented.





II. + III. Other Mitigation Tools + Repositioning

- Runway Extensions: Discussion on extending runways to allow for more options for operations.
 - Revisit in content of tower data to see if it makes sense.
 - In Master Plan but new data from tower will help better understand this option.
 - What are the costs to do this and benefits?
- Hangar 9 + Repositioning: Discussion re: to move forward on this or now. Comments:
 - The question still is, will the building of hangar 9 increase operations?
 - We need the space
 - Would like to have better maintenance facilities at Truckee Airport
 - Next step: bring back to future board meetings when have more time to review topic and discuss
- \circ Other ideas:
 - Buy Back Program:
 - Next steps: Peter to provide legal Memo re: this options and bring to future board meeting
 - Insulation, Part 150 Study, Noise Monitoring: Listed but not discussed due to time constraints
