DISCUSSION: The original estimate was as follows:

Item	Amount
Super Charger Parts	\$22,796.26
Labor Sierra Aero	\$5,057.50
Total	\$27,853.76

The revised cost is outlined below: The additional parts cost of \$1303.74 is association with Sierra Aero's purchase and holding of the parts as well as additional \$342.50 in associated labor. Additionally the sales tax of \$1807.50 is due based on the installation agreement. The total change in installation cost is \$3,453.74
