## GENERAL SHEET NOTES

- 1. SEE FLOOR PLANS FOR WINDOW SIZES AND FUNCTION
- 2. ALL EXTERIOR MATERIALS COMPLY WITH CHAPTER 7A OF THE CALIFORNIA BUILDING CODE. REFER TO SHEET A-GN FOR ADDITIONAL INFORMATION.
- 3. REFER TO TYPICAL FLASHING DETAIL FOR MINIMUM FLASHING AT DOORS AND WINDOWS.
- 4. ALL EXTERIOR LIGHTING SHALL BE IN COMPLIANCE WITH DEVELOPMENT CODE 18.30.060. EXTERIOR LIGHTS ARE REQUIRED TO BE FULL SHIELDED AND SHALL NOT TRESPASS ONTO ADJACENT PROPERTY OR THE PUBLIC RIGHT-OF-WAY
- 5. REFER TO SHEET A-GN & A-SP FOR PRODUCT SPECIFICATIONS AND CODE REQUIREMENTS, INCLUDING BUT NOT LIMITED TO:
   5.1 INSTALL EIRERLOCKING PER CODE. REEER TO SHEET A GN
- 5.1. INSTALL FIREBLOCKING PER CODE, REFER TO SHEET A-GN5.2. INSULATION MATERIALS SHALL HAVE A FLAME SPREAD INDEX AND
- SMOKE-DEVELOPED INDEX PER CODE, SEE ALSO SHEET A-SP DIVISION 7
  5.3. PROVIDE ½" GYP-BOARD AT WALLS AND CEILINGS IN UNDER-STAIR CLOSETS AND GARAGE W/ TAPE AND TEXTURE AND PAINT, (TYP). GARAGES BENEATH HABITABLE ROOMS ABV. SHALL BE SEPARATED FROM ALL HABITABLE ROOMS ABV. BY NOT LESS THAN A 5/8" TYPE "X" GYPSUM BOARD OR EQUIVALENT. INSTALL TYPE "X" AS REQUIRED BY CODE (REFER TO GENERAL NOTES SHEET A-GN FOR ADDITIONAL INFORMATION)
- 5.4. INSTALL STONE/MASONRY VENEER PER CODE, TYP. REFER TO GENERAL NOTES SHEET A-GN AND DETAILS FOR ADDITIONAL INFORMATION.
  5.5. FOOTINGS MUST BE PLACED IN UNDISTURBED SOIL, (SEE GENERAL NOTES SHEET A-GN)
- 6. REFER TO DETAILS FOR ADDITIONAL INFORMATION.
- 7. GENERAL CONTRACTOR IS TO BE RESPONSIBLE FOR ALL WATERPROOFING SYSTEMS. ARCHITECT IS AVAILABLE TO REVIEW ALL PROPOSED SYSTEMS PRIOR TO INSTALLATION. PROVIDE HORIZONTAL AND VERTICAL LAPS IN WATER-RESISTANT BARRIER(S) PER CODE. COORDINATE LAP LOCATIONS WITH DOOR/WINDOW FLASHING AS REQUIRED. PROVIDE FLASHING AROUND ALL WINDOWS AND DOORS PER TYPICAL FLASHING DETAIL
- 4. PROVIDE ENTRY DOOR PER CBC SECTION 1010:
- 4.1. THE FORCE REQUIRED FOR PUSHING OR PULLING OPEN INTERIOR SWINGING EGRESS DOORS, OTHER THAN FIRE DOORS, SHALL NOT EXCEED 5 POUNDS.
  4.2. THE DOOR ASSEMBLY SHALL COMPLY w/ THE APPLICABLE FIRE PROTECTION RATING AND, WHERE RATED, SHALL BE SELF-CLOSING OR AUTOMATIC CLOSING BY SMOKE DETECTION IN ACCORDANCE w/ SECTION 716.5.9.3, SHALL BE INSTALLED IN ACCORDANCE w/ NFPA 80 AND SHALL COMPLY w/ SECTION 716.
