#### NOMINATION OF CANDIDATES FOR THE GOVERNING BODY

1. Said election shall be to fill a vacancy for the following Board Member(s) who resigned and/or whose term(s) expired:

2. Said Directors for this District are elected in the following manner:

X At Large. There are no divisions in the District; all voters within the District vote for all candidates.

By Division

Districts are split into areas; only those voters residing in the area may vote for candidates who run in the area.

Qualified by Division-Elected at Large.

Directors must qualify to run by living in a specific division, but all voters within the District may vote on all candidates.

- 3. Said Directors has determined the following election particulars:
  - The length of the Candidate Statement shall not exceed <u>200</u> words.
  - The cost of the Candidate Statement shall be paid by the **Candidate**.
- 4. The District hereby certifies that:
  - There have been no District boundary changes since our last election, but the District understands that the Placer County Mapping Division will verify our District boundary lines prior to the election.

### MEASURE(S) TO BE SUBMITTED TO THE VOTERS (Non-applicable)

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Truckee Tahoe Airport District that the Board of Supervisors of the County of Placer is hereby requested to:

- 1. Consolidate the election with any other applicable election conducted on the same day;
- 2. The Truckee Tahoe Airport District has determined the following election particulars: in the case of a tie vote, the election shall be determined by Lot.
- 3. Authorize and direct the County Clerk, at Governing Body expense, to provide all necessary election services.
