Item 2 - Ad Hoc Committee Meetings Update

Non-Aviation Land Use Ad Hoc Committee (Directors Jones and Wallace)

- Staff and Legal Counsel are in process of drafting a Letter of Agreement (LOA) between TTAD
 and TTSA on the land Swap per the instructions received at the May 2018 Board Meeting. Staff
 anticipates final approval on LOA to come before both Boards in late July to end of August.
- There was agreement the SCIP proposal had merit and that GM would discuss with Town of Truckee, JMA, & Joergers regarding details of the creation of the Assessment District. This meeting is scheduled for Mid-July.
- Staff and Town of Truckee along with multiple other public agencies are working on the Truckee Tahoe-Public Agency Partnership Multi-site Planning Study.

GHG Inventory Study Ad Hoc Committee (Directors Wallace and Morrison)

- The Board received the final GHG Inventory at the Oct. 2018 Board Meeting.
- Staff and Consultant met on May 29th to review inventory details and mitigation strategies.
- Dylan Bonnie on our O&M Team is heading up this study. Staff anticipates presentation to the ad hoc committee in early Fall.

Economic Impact Study Ad Hoc Committee (Directors Wallace and O'Dette)

 Ad Hoc Committee will receive final draft of study on July 12th and will review draft with consultant on July 23, 2018 with presentation to Board and Public at the August 22, 2018 Board Meeting.

Hangar 2 Design and Programing Ad Hoc Committee (Directors Morrison and Stephens)

- Staff met with Mountain Lion Aviation on June 13th to discuss programming, budget needs, and MLA financial participation.
- Staff would like to discuss price and terms with the Board in closed session.

- Terms for a new agreement were discussed and agreed to by Soar Truckee, staff, and Ad Hoc Committee. The Final lease and details are included on this agenda for action.

Item 3 – Ponderosa Golf Course Lease Update and Irrigation System Replacement

TTAD and the Truckee Donner Parks and Recreation District signed a 10 year lease on June 12, 2008. TDPRD have indicated a desire to renew the lease for an additional 10 years. Staff plans to bring the Lease Renewal to the Board at the July 25, 2018 Meeting.

On a separate note, the TDPRD has asked TTAD for consideration of a request to potentially participate on the repair of the aging golf course irrigation system. I received the following email from Steve Randall, General Manager of the TDPRD.

Hi Kevin,

The lease for Ponderosa Golf Course was signed on June 12, 2008 for ten years. The lease is up and it is the intent of the Truckee Donner Recreation & Park District to renew the lease for another 10 year period.

As we discussed in our meeting, Ponderosa Golf Course has never had an automated irrigation system. It is currently being hand watered on a nightly basis. The existing piping for irrigation is over 40 years old and needs to be replaced. It is asbestos pipe and every year we are experiencing many breaks in the various lines. It is just a matter of time before the system completely goes and the golf course would have to be closed.

We need to put in new piping and an automated sprinkler system as soon as possible.

Attached is the estimate for the new sprinkler system. Costs are as follows:

Labor, materials, and installation of irrigation system \$948,000

Pump station \$150,232

Design and construction drawings \$25,000

TOTAL PROJECT COST \$1,112,232

As we discussed, TDRPD is looking for any funding assistance you might be able to give us for this project.

TDRPD and the Airport District have had a great relationship over the years. Thanks for your consideration of our request.
