AGENDA TITLE: Community Outreach Open House Events

**MEETING DATE:** Wednesday, August 22, 2018

**RECOMMENDED ACTION**: No board action is required at this time. This staff report is a follow-up to the Airport District's Community Outreach Open House events, and includes an update on the data and survey results collected.

<u>DISCUSSION:</u> In our efforts to continue public engagement and encourage feedback about the Truckee Tahoe Airport District from our constituents, two "Community Outreach Open House" events were held on Wednesday, June 13<sup>th</sup>, and Monday, July 9<sup>th</sup>, 2018.

Airport staff representing the District, along with representatives from all KTRK airfield SASO's (Specialized Aviation Service Operations) including REMSA - Care Flight, Mountain Lion Aviation, Sierra Aero, Skydive Truckee Tahoe, and Soar Truckee were present. Airport staff and our SASO partners were stationed around the room with various information topics, encouraging attendees to ask questions, learn about specific airport relationships and services, as well as District efforts and programs regarding Noise Abatement and Annoyance reduction. Attendees were also encouraged to leave feedback on station comment boards.

Beside the individual SASO informational stations, airport staffed station topics included: What have you done for me lately?, Airport Growth, Tower Operations and Noise and Annoyance Mitigation.

FreshTracks, our communications consultant, was also present and helped conduct three brief surveys with willing attendees. The survey topics included *Property Acquisition*, *Sound Insulation*, and *Community Outreach*.

Freshtracks estimated attendance at 35 for the first event and 24 at the second. The attendees appeared to be generally divided equally into two familiar groups, 1) noise and annoyance

impacted non-airport users from local neighborhoods, and 2) aviators and aviation users of the airport.

In conclusion, these Community Outreach Open House events are just one of the many methods that the District uses to engage our local constituents.

<u>PUBLIC COMMUNICATIONS:</u> As in years past for our Community Outreach events, the District managed a robust campaign to get the word out to our constituents about the two Community Outreach Open House events. Pre-event notification methods included: 1/4 page Sierra Sun newspaper ads, live 101.5 radio reads, neighborhood sandwich boards, community E-Blasts, and both website and social media posts.

#### **Overview of Input Process**

In efforts to continue public engagement and encourage feedback about the Truckee Tahoe Airport District, two community Open Houses were held on Wednesday June 13, 2018 and Monday July 9, 2018 at the District Community Room at the Truckee Tahoe Airport District. Airport staff and partners were stationed around the room with various information topics, encouraging attendees to learn about the specific airport relationships and services.

#### **Station Topics**

#### 1. What have you done for me lately?
