## DISCUSSION ITEMS: PI 311 COMMUNITY SPONSORSHIP/PARTNERSHIP POLICY

Mr. Smith reviewed the Community Sponsorship section and partnership section of PI 311 and the recent changes that were made to it earlier this year as well has the history of the giving program prior to the construction of the Policy. Discussion ensued regarding several specific concerns: staff oversight of the program and potential conflicts of interest, the "gift of space" for storage, external communication regarding the budget of the program, lack of strategic focus for the Agency Partnership Program. There was Member consensus to have the Board to consider a "global policy" that covers all investments, gifts, partnerships, sponsorships, non-profit reduced rent warehouse space (i.e. Tahoe Food Hub, Project Mana) and free storage. Further suggestions by the Members noted a need for the public agencies to be the "lead player" regarding the Agency Partnerships Program, not the non-profits; as well as the notion of the Policy needing to have a more intent framework for decision making and the selection process, currently

the policy is not written to back up the Board's decision making. Mr. Smith acknowledged all of the notes and suggestions, and will bring them to the Annual Strategic Board workshop on July 8<sup>th</sup>. Mr. Smith noted that the Board will be discussing other high priority subjects and that PI 311 will only be a 30-45 minute topic, as the entire meeting is only 3 hours in length.

## ACTION ITEMS: EMERGENCY LANDING LOCATIONS - POTENTIAL AD HOC PROJECT

Member Diamond reviewed his potential project and the value it would bring to the Airport District and the pilot community.
