## 21 DISCUSSION AND ACTION REGARDING PROCESS AND TIMELINE TO FILL BOARD VACANCY (TAB 01)

22 District Counsel Nelson reviewed his memo explaining the procedures for filling a Board Vacancy for the 23 Board of Directors. District Counsel Nelson noted that the Board has two basic options: (1) appoint 24 someone to fill the vacancy or (2) call a special election to do so. The appointee will serve the remainder 25 of Director Morrison's term until 2022. District Counsel Nelson stated that Pursuant to Government Code 26 Section 1780(a), the Board may appoint a successor within sixty days of the resignation. Therefore, the 27 Board has until October 25th to make an appointment. And that the Placer and Nevada Counties elections 28 officials must be notified of the appointment no later than fifteen days after the appointment. If the Board 29 were to choose to call a special election, the Board must call the election by October 25, 2020. The election 30 will be held on the next established election date that is 130 or more days after the date the District calls 31 the election. The next available election date would be the first Monday in March next year, March 9, 32 2021. 33 The cost of the Special election would solely be funded by the District (unless there is another entity that

133 The cost of the special election would solely be funded by the District (unless there is another entity that 134 has an issue to place on the ballot, the cost would be shared) with an estimated cost of \$100,000+. An 135 exact cost will be provided to the Board as soon as it is received by staff. If the Board of Directors fail to 136 exercise either of the two options stated previously, the Placer County Board of Supervisors may fill the 137 vacancy by appointment within ninety days of the date the District is notified of the vacancy. If Placer 138 County Board of Supervisors does not fill the vacancy or call an election, the District must call an election 139 to fill the vacancy.

- Discussion ensued regarding hangar tenants applying for the vacancy (potential conflict of interest), candidates running in the general election being able to apply for the vacancy, candidates having a
- 42 business relationship outside of the District with sitting Board Members, amount of posting locations for

- the vacancy notice, continued discussion of the cost of calling a special election, and each Director's
- 44 preference of calling a special election or having the Placer County Board of Supervisors appointing.
- 45 PUBLIC COMMENT: Mr. Andrew Terry, Truckee resident, made a public comment regarding the
  46 appointment of Ms. Katie Morrison's replacement, and that a process was done before. Mr. Terry also
  47 noted that there is more than 10k voters within the Airport District.
- 48 Mr. Matt Miller, Truckee resident, made a public comment about a "set up" of Mr. Jones replacing Mr.
  49 Morrison due to their friendship and not to let it happen.
- 50 Ms. Danielle (did not make out last name), Reporter from the Sierra Sun, made a public comment 51 regarding the total amount of voters in Placer County.
- 52 There was Board consensus to post the Board vacancy announcement in multiple locations throughout
- 53 the community, as well as multiple social media platforms and the District website. Applications will be
- accepted by Ms. Lauren Tapia until 5:00 PM on September 30, 2020. A special Meeting will occur on
- 55 October 13, 2020 at 1:30 PM, for the Board to review applications with possible selection taking place at
- that meeting. If an agreement cannot be made, the Board will decide whether to call a Special Election.
- 57 There was also consensus for a completed CA Form 700 to be included with the vacancy application, which
- 58 will assist in providing some transparency of any potential conflicts of interest.
- 59 Discussion ensued regarding interviewing Candidates. There was consensus to have the Board conduct, if
- 60 they wish, individual off-line interviews. District Counsel Nelson stressed the importance of Board
- 61 members to not discuss their interviews with the candidates with other Board members, and for the
- 62 candidates to not talk to other candidates about their interviews with the Board members to assure Brown
- 63 Act compliance.
