19 **SELECTION PROCESS FOR APPLICANTS TO THE BOARD OF DIRECTORS VACANCY (TAB 01)**

20 District Counsel Nelson reviewed his staff report outlining how to move forward with filling the vacancy
21 on the Board of Directors created by Director Morrison’s resignation. District Counsel Nelson reviewed
22 the Board’s decision at the September 4th Special meeting not to conduct public interviews of the
23 applicants at the scheduled October 13th Special meeting. District Counsel Nelson noted that today’s
24 special meeting was requested by Vice President Hetherington to review the process again, and to
25 generally discuss the process for considering applicants and potentially making an appointment to fill the
26 vacancy.

27 Vice President Hetherington noted the opinion piece written in the Nevada Union about the Board’s
28 decision to conduct private interviews, and that the Board should reconsider their decision made at the
29 September 4th Special meeting. Discussion ensued regarding the amount of open questions the Board
30 Members would ask whether those questions be written and sent prior or asked at the time of the
31 meeting, how the applicants would respond, as well as the selection process of the virtual straw poll.
32 There was Board consensus to not send questions for applicants to respond and have those responses
33 posted with the agenda on the District’s website, but instead verbally ask their questions in real time at
34 the October 5th Special Board meeting. Members of the public will have the ability to suggest a question
35 during the initial public comment period, and that it would be at the Board Member(s) discretion to ask
36 the suggested question. The Board will also conduct a virtual straw poll where the applicants would be
37 listed in alphabetical order by surname and the Board will rank them, verbally, when asked by District
38 Counsel Nelson. A motion (or multiple motions) can/will be called after the conclusion of the straw poll.
