



Operations (Exhibit 1)

- 3,280 operations, a 29% increase from 2019 and a 50% increase from 2018
- Helicopters up 58%, Jets up 73%, Pistons up 19%, Turboprops up 44% from October 2019
- Thursday, October 22 2020 was the busiest day of the month with 232 operations (busiest day of 2020 was August 9 with 361 operations)
- F18 did low approach October 1 and October 30
- U2 spy plane flew pattern work on Runway 29 October 8 & October 21

Exhibit 4a: October 2020 Noise Comment Heap Map (5 mile radius)

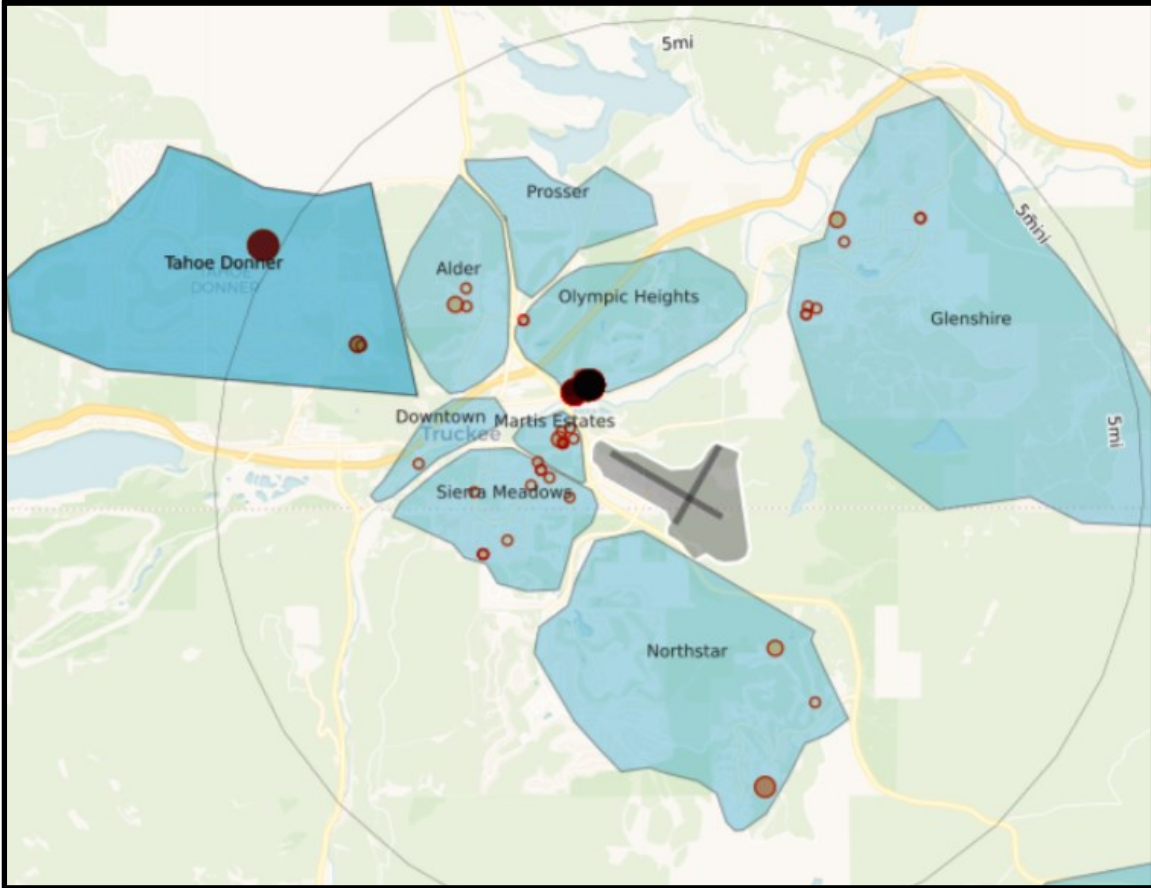


Exhibit 4b: October 2020 Noise Comment Heap Map (full district)
