TTAD - History of ANAC / ACAT

KTRK ACAT – Founded in 2005

- Intentionally set up as its own group with its own budget – not a political element of the Board
- Enhance benefit to the community at large
- Work on solutions to reduce noise and annoyance
- Six member structure of community input plus pilot acumen aims to produce viable and constructive solutions



Structure of Community Airport Groups

- Dependent on Governing Structure of Airport
 - Appointed by Governing Body
 - Appointed by Individual Governing Body Members
 - Ad-Hoc / Sub Committee (Chairperson)
 - Appointed by Geographic District as Representative



Airport Community Advisory Groups and Roundtables

Size and Composition

- Size Varies
 - As few as Committee Chair and Airport Staff
 - As many as 30 members
- Variety – Inclusively Represent Airport Stakeholder Interests
 - Relate to function of group
- Meeting Frequency – Monthly to Annually
 - size dependent



Airport Community Advisory Groups and Roundtables

Function - Commonalities

- Advise and Provide Recommendations to Governing Board
- Inform on Decision Making Processes
- Improve Public Communication and Public Input

Function - Differences

- Strategic Function (Policy Focus)
- Tactical Function (Project Focus)
- Broad or Specific - Land Use, Public Outreach/Marketing, Noise

Citizens Noise Advisory Committee

- 15-members (11 appointed by local jurisdictions in region, Port names 4 members)
- Review noise abatement projects, develop ideas and recommend proposals for consideration
- Promote citizen understanding of airport noise issues
- Form technical sub-groups





Airport Community Advisory Groups and Roundtables

SFO Airport Community Roundtable

- 20-members (Appointed by local jurisdictions in region, Board of Supervisors)
- Subcommittees – Legislative, Ground-Based, Technical
- Monitor performance-based noise mitigation program
- Interprets community concerns
- Mitigate noise through cooperation with FAA, SFO Management, aviation industry and local governments





Airport Community Advisory Groups and Roundtables

RNO Airport Noise Advisory Panel Committee (ANAP)

- 25 citizen members (Appointed by 3 local jurisdictions)
- Meet twice annually
- Mission:
 - *Receive and assess information on airport noise issues*
 - *Assist in coordination between noise sensitive, off airport land use activities and noise generating airport activities*
 - *Promote greater communication regarding airport noise among the various public bodies, agencies, and commissions*
 - *Make advisory recommendations to the Airport Authority Board of Trustees regarding new and existing programs and approaches to noise abatement*

Air Service, Marketing and Community Relations Committee



- Consists of Two Appointed Board Members serving as Chairs
 - Reviews Noise Reports
 - Meets with HOA's of noise affected neighborhoods
 - Reviews Passenger Comments

Aspen/Pitkin County Airport Airport Vision Committee

- Airport Visioning Committee has 21 members
- Broad, Master Plan Focus
- Appointed by Board of Supervisors
- Comprised of Four Working Groups
 - Technical Working Group

 - Community Character Working Group
 - Focus Group
