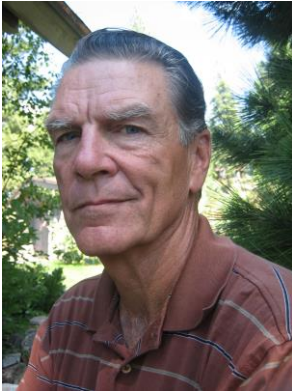

John has been a resident of the Truckee area for almost 12 years and has had a home in the District since the early 70's. He is a passionate instrument rated pilot, spent 8 years on the TTAD Board and was president for 2 of those years. He received over 5,000 votes in the 2018 election coming in a very close 3rd. During his 8 years on the TTAD Board, he worked to balance the needs of the aviation community with the needs of the airport neighbors, which his voting record during those 8 years will confirm.

Having spent almost 50 years in the Tahoe area, John felt he needed to give back and in 2016 he joined the Board of the Tahoe Fund and heads a committee focused on Forest Health in the Tahoe Basin focusing on ways to improve the pace and scale of forest management in The Basin.

John has been the President of his own Investment Management Company since his retirement from Wall Street in 2005 and has found time to open a small commercial real estate company and a property management company in the local community.

When John retired, he left a career as a Wall Street Equity Analyst following the Computer Industry. His career started at Montgomery Securities in 1985 and during the following 20 years he worked for Salomon Brothers, Salomon Smith Barney, Citicorp, SoundView Technology Group and Charles Schwab.

Prior to his career on Wall Street, John spent 18 years in the computer industry joining IBM in 1968.
