This letter is to announce my interest in putting my name forward for consideration for filling the vacant Truckee Tahoe Airport District Board seat. I think I would bring some useful qualifications to the team, notably ...

-  In 2016 I ran for a board seat and lost, by 111 votes, in a tightly contested election. Over 5,000 people voted for me.
-  I am a past member of ACAT and have served multiple terms as the chair and have also been the treasurer
-  I have attended public meetings pertaining to the airport including those held by the Town of Truckee Council, Foothill Area Land Use Commission, ACAT, and Truckee Tahoe Airport District Board for an extended period of time. Hence I have a history of actions that have been tackled and a knowledge of the issues involved
-  Despite being a non-aviator I am generally more educated about aviation matters than a typical member of the general public
-  As a statistician by training, and corporate information consultant by profession, I am comfortable using (incomplete) data to derive information and hence facts and insights
-  I reside within the airport influence area, am negatively impacted by airport operations, and realize that there is a set of problems that must be addressed to maintain a viable local airport
-  As an active member of the community interested in the airport I have heard from many residents throughout the TTAD about their issues regarding airport operations

So, again, I present myself for consideration for the vacant Truckee Tahoe Airport District Board seat and commit to working within a team environment to generate recommendations that satisfy as many stakeholders as possible while addressing some of the airport operations caused land-use, noise, pollution, safety, and security problems.
