## Ramp & Services:

• Tenant moved barricades and cones from a construction area in order to taxi from his hangar to the runway. Prior notice to area closure had been communicated with all affected hangar tenants. An O&M Supervisor was present and had a discussion with the tenant.

## Airfield:

- 5 Trespassing events
  - o 2 jogger, 1 hiker, 1 snowshoe & 2 sledding occurrences.

## Aviation

- 3 incursions
  - Morning, before Tower was opened, an aircraft took off Runway 29 while transmitting on Ground frequency. O&M vehicle was conducting Runway 02/20 inspections and correctly transmitting on CTAF.
  - Morning, before Tower was opened, an aircraft took off Runway 11
    without making radio calls (student pilot had dialed in the wrong
    frequency) while O&M vehicle was conducting Runway 02/20 inspections
    and correctly transmitting on CTAF.
  - Morning, before Tower was opened, an airport owned backhoe crossed Runway 02 without making radio calls on CTAF. There were no aircraft operations in the vicinity.

#### Hangars

- 4 Hangar door momentary safety switches bypassed. A proposed Policy Instruction will be presented to the Board in March to clarify enforcement actions.
  - o 3 First offenses
  - o 1 Second offense
- Damaged hangar man door. Replacement \$756.78. Shipping \$509.12
- Original lower cable mounts were found to be improperly welded increasing the potential for a hangar door failure.
  - All hangars are being checked during the 1<sup>st</sup> Quarter hangar inspections and discrepancies logged for repair.
- Unapproved electrical outlets were found to be incorrectly wired. Additional outlets had been added sometime over the years.
  - All hangars are being checked for unauthorized electrical outlets during the 1<sup>st</sup> Quarter hangar inspections and logged for the Facilities Maintenance Manager.
