22 **PUBLIC COMMENT:** Mr. Tom Meadows, Truckee resident, made a public comment stating that the airport

23 land along Soaring Way should only be utilized for aeronautical purposes or preserved as an open space

24 safety buffer and that the District should not do non-aviation land leasing on that property.

### 25 **REVIEW OF DISTRICT MISSION STATEMENT**

26 Mr. Smith suggested a review and possible update to the District Mission Statement and proposed the 27 addition of the word "safe" as was recommended during the recent safety gap analysis, and a change 28 from striving for "low" impact to striving to "reduce" impact. Discussion ensued amongst the Board. There 29 was discussion that the placement of Safe only referenced aviation safety and that a more Broad 30 statement would be more appropriate. There was discussion regarding neighborhood safety and how the 31 mission statement could reflect that need also. Board Members provided various options and edits. 32 There was Board consensus to direct staff to gather these options and edits and bring forward verbiage 33 options for Board review and action at the July meeting.

# 35 **2022 DISTRICT GOALS AND BUDGET DISCUSSION**

Mr. Smith reviewed the staff report on goal setting and SOAR (Strengths, Opportunities, Aspirations, Results) as a tool for goal setting framework. Staff and each Board member provided their SOAR analysis. Potential budget opportunity topics discussed amongst the Board and staff included: regional workforce housing, regional GHG collaboration planning/group, long term air traffic control tower plan, hangar roof replacement options, greenhouse gas initiatives, master planning, electric aircraft, EAA building facility options, community sponsorships and partnerships, a local aviation scholarship program, rates, fees, and

42 charges review, continued flight procedures development, and education/outreach opportunities for the 43 public, pilots and the Board, a top down communications strategy as well as updates and upgrades to

- 44 District website and social media. There was Board consensus to bring forward these budget
- 45 opportunities and appropriate goal alignments for Board discussion and action at the next Board budget
- 46 development meeting in August.
- 47 PUBLIC COMMENT: Mr. Tom Meadows, Truckee resident, made a comment regarding shade hangars 48 being inappropriate for the Truckee climate, and objected to Very Light Jet fees. He spoke in support of 49 an aviation scholarship program and finding a solution to improve community hangar space.

#### 50 WEBSITE, SOCIAL MEDIA, AND NEWSLETTER DISCUSSION

51 Mr. Smith spoke to the existing website, social media, and newsletter programs and some upcoming 52 vendor service contract review opportunities. Discussion ensued amongst the Board regarding the over-53 arching web and social media communication strategies, improving the mobile functionality of webpages, 54 the role of the airport in promotion of airfield commercial businesses, and the value of printed/mailed 55 media. Various communication strategies were discussed including the effectiveness of the District 56 Newsletter, proposed updates and revisions to the website, and who should select airport issues to 57 highlight. There was not clear Board consensus on changing the Newsletter program, highlighting 58 business at the airport, or direction on the overall communications program of the District at this 59 workshop. There was consensus amongst the Board to continue discussing the development of a top-60 down communication strategy and content policy at a future meeting and to include this topic in our 2022 61 Budget discussion. Staff did confirm that they would not publish another issue of Connected without 62 Board input on topics and stories. The next edition is Fall of 2021. 63

#### 64 POSSIBLE LAND ACQUISITION WITH FOREST SERVICE

65 Mr. Smith reviewed a workforce housing development and open Space opportunity on Forest Service land 66 that the U.S. Forest Service is exploring, along with a potential partnership with the JPA. As a result of this 67 potential development, he was made aware of Forest Service surplus property that will be sold to highest 68 bidder and that they may offer an opportunity for the Airport or other public agency purchase via a 69 partnership with the Truckee Donner Land Trust. Discussion ensued amongst the Board. There was 70 consensus among the Board to continue to explore the purchase opportunity and bring back more 71 information at a future meeting for discussion. 72 PUBLIC COMMENT: None
