We should be doing more community events, not less.

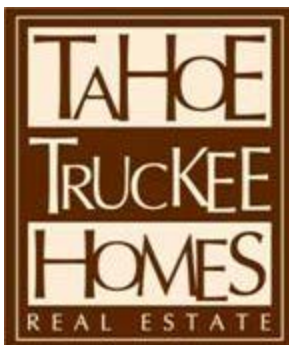

Dear Truckee Tahoe Airport Directors,

I have been watching your virtual meetings and have found the discussion on the air show very compelling. It is clear there is support for this event from some people in the community and some outside supporters. It is also clear there are a lot of concerns about holding the air show as currently proposed.

First, I am concerned about the use of tax payer funds for this very short duration and very expensive event. I see there have been adjustments made to lower the cost and reduce the performers. However, \$189,350 could be used in so many other ways that are more supportive of our community needs. I think these funds could be leveraged in other ways to support the non-profits that benefit from this event.

Second, the environmental impacts of this event are massive. There are many people within our community that are very concerned about this impact. I have received multiple emails asking that the Town of Truckee shut down the air show. The Town Council has a very strong set of goals and most of them focus on environmental stewardship. The air show is incongruous with our current community direction.

Lastly, the Town of Truckee was named in the lawsuit regarding the recent jet crash. I am very concerned about the personal risk the Directors and other elected official face with an air show like this. We are all painfully aware of the 11 deaths from the Reno air races in 2011. I do not want to put our community at risk and our agencies at risk of potentially devastating lawsuits. Please protect our community and request the air show transition to a land only event.
