The above-referenced PROJECT requires an Amendment. The work in this Amendment is in addition to the Scope of Services stated in the original Work Order 1 between the CLIENT (Truckee-Tahoe Airport District) and the CONSULTANT (Mead & Hunt, Inc.) dated May 1, 2018, and any amendments made to that work order.

The CLIENT agrees that the CONSULTANT will provide professional consulting services for the PROJECT as set forth in this Amendment and the CLIENT shall provide payment for those services as provided for in this Amendment.

A detailed description of our understanding of the Amended PROJECT Scope of Services, Schedule, and Compensation is provided below.

#### **Reason for Amendment**

This Amendment is to add money to the existing contract / work order for miscellaneous planning services occurring from March 28, 2022 to January 31, 2023.

### **Amended Scope of Services**

The Scope of Services for this amendment consists of: Miscellaneous Services for Planning during part of 2022 through January 31, 2023. These services include:

- Minor "on-call' tasks such as (but not limited to): initial studies, map updates, research, FAA coordination.
- Services not associated with other Task Orders (which include the Airport Master Plan Update, Land Releases, the geographic information systems (GIS) on-call contract, and other future Task Orders).

### **Amended Compensation**

Form of compensation for work in this Amendment will be in accordance with the Terms and Conditions of the existing CONTRACT. The Truckee-Tahoe Airport District will pay Mead & Hunt, Inc. an increase of **Thirty Thousand Dollars** (\$30,000) for the work performed under this Amendment. This Amendment results in a revised total contract amount of One Hundred Seventy-two Thousand Five Hundred Dollars (\$172,500).

#### **Authorization for Amendment**

Signatures of authorized representatives of Truckee-Tahoe Airport District and Mead & Hunt, Inc. shall amend the existing Agreement (original CONTRACT, Work Orders, and previous amendments, if applicable) between the two parties, and receipt of one signed copy shall be considered authorization to proceed with the work described in this Amendment. All services will be performed in accordance with the Terms and Conditions of the original Master Services Agreement dated March 28, 2018, and Work Order 1, signed May 9, 2018.
