




Item 4. Updated Airport Master Plan Schedule, Phase 1

Item 5. Truckee Tahoe Airport District Land Use Compatibility Zones




Here's info from 2016 ALUCP:

 Zone C: Residential uses restricted to a density of 0.2 du/ac (5-acre parcels); overflight easement required

- Zone D: Residential density must be kept low (5-acre parcels or larger) or high (5 du/ac or higher).
- CNEL 60 dB: Max acceptable exterior noise exposure for residential uses (e.g., no RES in 60 dB contour)

There is some guidance from the FAA in the <u>draft Airport Land Use Compatibility Planning advisory circular.</u>





#### Item 6.

The Town of Truckee is excited to announce that TART Connect will launch on June 25, 2022. The free, on-demand, shared shuttle service, currently operating in North Lake Tahoe, will expand to the Truckee area as a pilot project throughout the summer.

The Truckee TART Connect Pilot Program is a service that aims to meet more transit needs, especially for those seeking to travel to and from our residential areas without using their cars. Service will operate 7 days a week from 10 AM to 10 PM. TART Connect users can download the TART Connect app and enjoy the free service in Tahoe Donner, the Downtown commercial core, Glenshire, and the Tahoe Forest Health System zone. Riders can also make connections from the Truckee Train Depot and Truckee Tahoe Airport to North Lake Tahoe by the TART fixed route bus

system (not included in TART Connect App). Once in North Lake Tahoe, riders can request rides within the North Shore's TART Connect service zones.

The TART Connect app is available on both iOS and Android for you to set up your account now. For more information about this program and regional transportation services, visit TahoeTruckeeTransit.com.

**Item 7.** Truckee Tahoe Airport District & Truckee Tahoe Community Foundation Agency Partnership.

- Lesson learned from the previous cycle are being discussed, and finalizing modifications to processes, review, and approval are critical to continuous process improvement.

**Item 8.** Caltrans Division of Aeronautics, State permit compliance inspection, May 24, 2022. See correspondence below. Great inspection overall, with 2 areas for corrective action. A Corrective action plan is being developed and will be back briefed.

The California Department of Transportation (Caltrans), Division of Aeronautics, conducted a State permit compliance inspection and Federal Aviation Administration (FAA) Airport Master Record (Form 5010-1) update of Truckee-Tahoe Airport (FAA Site No. 02366.\*A) on May 24, 2022. We appreciate meeting with you and touring the airport with Stacy Justesen.

During the inspection, it was apparent that the airport has made significant progress in removing obstructions from the Code of Federal Regulations (CFR) Part 77 imaginary surfaces and airport safety areas. We commend your efforts and understand that the clearing project is ongoing. We also acknowledge the successful completion of the runway remarking and the Taxiway A paving and marking project.

The airport was evaluated using the State Airport Permit, the latest Airport Layout Plan, and previous inspection letters. The updated information will be entered into State records and the FAA Form 5010-1. Our inspection revealed the following items listed in order of priority which we now bring to your attention:

- 1. Trees from 400 to 600 feet north of the Runway 11/29 centerline and 500 feet west to 800 feet east of the Runway 11 Threshold penetrate the CFR Part 77, 7:1 Transitional Surface by as much as 20 feet. These trees should be removed or trimmed, as shown in enclosed Photograph 1, so they do not penetrate the Transitional Surface. This is a repeat discrepancy.
- 2. Obstruction lighting located atop Bald Mountain, approximately 2.21 nautical miles southwest  $(39^{\circ}\ 17'\ 48.28''\ N\ /\ 120^{\circ}\ 10'\ 53.92''\ W)$  of the Runway 1 threshold, has become obscured by trees

and is no longer visible from the airport (please see enclosed Photograph 2). The surrounding trees must be trimmed to a height below the level of the obstruction light so that the obstruction light is visible to departing/arriving aircraft or be removed. This is a repeat discrepancy.
