

RESOLUTION NUMBER 2022-10
OF THE TRUCKEE TAHOE AIRPORT DISTRICT

TO ACKNOWLEDGE AND APPROVE THE AIRPORT CAPITAL
IMPROVEMENT PROJECTS FOR 2023-2032

WHEREAS, the Truckee Tahoe Airport District and the Federal Aviation Administration annually participate in Federal Airport Improvement Program; and

WHEREAS, the California Department of Transportation, pursuant to the Public Utilities Code section 21683.1, provides grants up to 5% of Federal Aviation Administration grants to airports; and

WHEREAS, the Federal Aviation Administration and the California Department of Transportation encourages and/or requires the Board of Directors to adopt a resolution authorizing the submission of an application for AIP Matching grants as well as authorize signatories;

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Truckee Tahoe Airport District:

1. Authorizes filing an application for Federal and State AIP Matching grant for the following projects:
 - I. (AIP) Reconstruct Existing Runway 02-20 with Airfield Lighting.
 - II. (AIG) New Snow Removal Equipment – Loader.
 - III. Other Projects on the approved ACIP which may be eligible for funding.
2. Authorizes accepting the allocation of Federal and State AIP Matching funds for this project.
3. Authorizes execution of Federal AIP Grants and State AIP Matching Grant Agreements for this project; and

BE IT FURTHER RESOLVED that the Board of Directors of the Truckee Tahoe Airport District does hereby authorize ROBB ETNYRE, General Manager of the Truckee Tahoe Airport District, to sign any and all documents required to apply for, accept, and process these subject funds on behalf of the Truckee Tahoe Airport District.
