There was a TTWHA Board meeting on October 19<sup>th</sup>. The Board reviewed the annual audit, which had no additional comments,

and was approved. The Executive Summary, 2022 Annual Employee Survey, TTWHA Housing Program and project updates were reviewed. TTWHA Long-term Rental Home Listing stats: July 2022 — September 2022, 15 homes were listed and advertised to TTWHA member agency employees, 5 homes were filled, and 1 home is currently pending. All homes that are not filled are released. Please review the attached documents for further information.
