## Downtown River Revitalization Strategy

The Town of Truckee R2SC held its second meeting on September 5, from 5-7pm. The committee approved a Request for Proposal to find a consultant specializing in town and river revitalization. The Town of Truckee, with the committee, is also working with East River PR to begin some basic messaging on what the R2SC is doing, where the 'Project Area' is, as well as the 'Sphere of Influence.' Between now and the next meeting Town Planners will set up a series of times to drive/walk R2SC members down the length of the Project Area (Highway 89 to 267 By-Pass Bridge) to highlight the complexity of the mixed land use and zoning issues.
