WHEREAS, District entered into an Agreement for Aviation Engineering Services with the Engineer dated the <u>25th</u> day of <u>January 2023</u> to perform engineering design work, including design and construction supervision, for development of the Truckee Tahoe Airport, and

WHEREAS, District desires Engineer to perform specific services under the said Agreement,

NOW, THEREFORE, IN CONSIDERATION OF the covenants and agreements herein set forth, it is hereby agreed:

This agreement supplements said Special Services Agreement, and the terms of said
 Agreement apply hereto.

2. **Project**

The project covered by this Supplemental Services Agreement shall include the Preliminary Engineering and Engineering Design through Plans and Specifications for the following work at the Truckee Tahoe Airport:

> Reconstruction of Apron A2 (239,000 sq. ft.)

3. Scope of Work

Phase 1 - Preliminary Engineering:

- a) Prepare environmental documents including Categorical Exclusion (NEPA).
- b) Perform detailed topographic surveys.
- c) Perform geotechnical studies and pavement design.

Phase 2 - Engineering Design and Preparation of Plans and Specifications

- a) Perform complete engineering design.
- b) Prepare complete plans and specifications for this project, ready for bid.
- c) Prepare Engineer's Report including engineer's estimate of construction costs for the proposed project, the Construction Safety and Phasing Plan, and the Construction Management Plan.

4. *Compensation*

As full compensation for all work or services to be provided by Engineer hereunder,
District shall make payments to Engineer at the times and in accordance with the procedures set forth
in the Special Services Agreement and at the rates set forth herein:

Environmental Documentation	\$ 3,500
Topographic Surveys	18,000
Geotechnical Studies and Pavement Design	30,000
Engineering Design, Plans, and Specifications	177,000
Total Compensation – Not to Exceed	\$ 228,500

These services will be performed at standard hourly rates as set forth in Exhibit A to this agreement. The total fee under this agreement will not exceed \$228,500 without prior approval of the Truckee Tahoe Airport District.

5. <u>Time of Completion</u>

The Preliminary Engineering and Engineering Design through preparation of Plans and Specifications will be completed within one-hundred eighty (180) days of receipt of authorization to proceed.

6. Federal Compliance Requirements

The Contract Provisions for Obligated Sponsors and Airport Improvement Projects included in Exhibit B of the Agreement for Aviation Engineering Services are deleted. These Federal Compliance Requirements are replaced with the Contract Provisions for Obligated Sponsors and Airport Improvement Projects included in Exhibit B to this supplemental agreement.

The prime contractor agrees further to return retainage payments to each subcontractor within 7 days after the subcontractor's work is satisfactorily completed. Any delay or postponement of payment from the above referenced time frame may occur only for good cause following written approval of the Truckee Tahoe Airport District. This clause applies to both DBE and non-DBE subcontractors.

Termination of DBE Subcontracts (49 CFR § 26.53(f))

The prime contractor must not terminate a DBE subcontractor (or an approved substitute DBE firm) without prior written consent of Truckee Tahoe Airport District. This includes, but is not limited to, instances in which the prime contractor seeks to perform work originally designated for a DBE subcontractor with its own forces or those of an affiliate, a non-DBE firm, or with another DBE firm.

The prime contractor shall utilize the specific DBEs listed to perform the work and supply the materials for which each is listed unless the contractor obtains written consent Truckee Tahoe Airport District. Unless Truckee Tahoe Airport District consent is provided, the prime contractor shall not be entitled to any payment for work or material unless it is performed or supplied by the listed DBE.

Truckee Tahoe Airport District may provide such written consent only if Truckee Tahoe Airport District agrees, for reasons stated in the concurrence document, that the prime contractor has good cause to terminate the DBE firm. For purposes of this paragraph, good cause includes the circumstances listed in 49 CFR §26.53.

Before transmitting to Truckee Tahoe Airport District its request to terminate and/or substitute a DBE subcontractor, the prime contractor must give notice in writing to the DBE subcontractor, with a copy to Truckee Tahoe Airport District, of its intent to request to terminate and/or substitute, and the reason for the request.

The prime contractor must give the DBE five days to respond to the prime contractor's notice and advise Truckee Tahoe Airport District and the contractor of the reasons, if any, why it objects to the proposed termination of its subcontract and why Truckee Tahoe Airport District should not approve the prime contractor's action. If required in a particular case as a matter of public necessity (e.g., safety), Truckee Tahoe Airport District may provide a response period shorter than five days.

In addition to post-award terminations, the provisions of this section apply to preaward deletions of or substitutions for DBE firms put forward by offerors in negotiated procurements.

The Contractor will take such action with respect to any subcontract or purchase order as may be directed by the Secretary of Labor as a means of enforcing such provisions, including sanctions for noncompliance: *Provided*, however, that in the event the contractor becomes

involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the Contractor may request the United States to enter into such litigation to protect the interests of the United States.

Owner agrees to make just and equitable compensation to the Consultant for satisfactory work completed up through the date the Consultant receives the termination notice. Compensation will not include anticipated profit on non-performed services.

Owner further agrees to hold Consultant harmless for errors or omissions in documents that are incomplete as a result of the termination action under this clause.

TERMINATION FOR CAUSE (PROFESSIONAL SERVICES)

Either party may terminate this Agreement for cause if the other party fails to fulfill its obligations that are essential to the completion of the work per the terms and conditions of the Agreement. The party initiating the termination action must allow the breaching party an opportunity to dispute or cure the breach.

The terminating party must provide the breaching party [7] days advance written notice of its intent to terminate the Agreement. The notice must specify the nature and extent of the breach, the conditions necessary to cure the breach, and the effective date of the termination action. The rights and remedies in this clause are in addition to any other rights and remedies provided by law or under this agreement.

- a) **Termination by Owner**: The Owner may terminate this Agreement for cause in whole or in part, for the failure of the Consultant to:
 - 1. Perform the services within the time specified in this contract or by Owner approved extension;
 - 2. Make adequate progress so as to endanger satisfactory performance of the Project; or
 - 3. Fulfill the obligations of the Agreement that are essential to the completion of the Project.

Upon receipt of the notice of termination, the Consultant must immediately discontinue all services affected unless the notice directs otherwise. Upon termination of the Agreement, the Consultant must deliver to the Owner all data, surveys, models, drawings, specifications, reports, maps, photographs, estimates, summaries, and other documents and materials prepared by the Engineer under this contract, whether complete or partially complete.

Owner agrees to make just and equitable compensation to the Consultant for satisfactory work completed up through the date the Consultant receives the termination notice. Compensation will not include anticipated profit on non-performed services.

Owner further agrees to hold Consultant harmless for errors or omissions in documents that are incomplete as a result of the termination action under this clause.

If, after finalization of the termination action, the Owner determines the Consultant was not in default of the Agreement, the rights and obligations of the parties shall be the same as if the Owner issued the termination for the convenience of the Owner.

- b) **Termination by Consultant**: The Consultant may terminate this Agreement for cause in whole or in part, if the Owner:
 - 1. Defaults on its obligations under this Agreement;
 - 2. Fails to make payment to the Consultant in accordance with the terms of this Agreement;
 - 3. Suspends the project for more than [180] days due to reasons beyond the control of the Consultant.

Upon receipt of a notice of termination from the Consultant, Owner agrees to cooperate with Consultant for the purpose of terminating the agreement or portion thereof, by mutual consent. If Owner and Consultant cannot reach mutual agreement on the termination settlement, the Consultant may, without prejudice to any rights and remedies it may have, proceed with terminating all or parts of this Agreement based upon the Owner's breach of the contract.

In the event of termination due to Owner breach, the Consultant is entitled to invoice Owner and to receive full payment for all services performed or furnished in accordance with this Agreement and all justified reimbursable expenses incurred by the Consultant through the effective date of termination action. Owner agrees to hold Consultant harmless for errors or omissions in documents that are incomplete as a result of the termination action under this clause.

TRADE RESTRICTION CERTIFICATION

By submission of an offer, the Offeror certifies that with respect to this solicitation and any resultant contract, the Offeror –

- 1) is not owned or controlled by one or more citizens of a foreign country included in the list of countries that discriminate against U.S. firms as published by the Office of the United States Trade Representative (USTR);
