Report on Appropriations Limit Calculation

We have performed the procedures enumerated below solely to assist the Truckee Tahoe Airport District in the calculation of the appropriations limit for calendar year 2024 in order to meet the requirements of Section 1.5 of Article XIII B of the California Constitution. This engagement was conducted at the request of management of the Truckee Tahoe Airport District. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.


Procedures and Results

1. We agreed the prior year appropriations limit of \$9,726,699 used in the accompanying worksheets to the calendar year 2023 appropriations limit calculation.
2. We recalculated the population percentage change factor of 1.0005 used in the accompanying worksheets based on the weighted average percentage change of assessed values for Placer and Nevada County.
3. We recalculated the growth factor of 1.0444 used in the accompanying worksheets.
4. We recalculated the calendar year 2024 appropriations limit of \$10,164,400 in the accompanying worksheets.
5. We agreed the 2024 budgeted proceeds of taxes of \$8,702,638 used in the accompanying worksheets to the District's 2024 budget.
6. We recalculated the interest income attributable to tax proceeds of \$56,693 used in the accompanying worksheets.

7. We recalculated the excess of appropriations limit over budgeted appropriations of taxes of \$1,405,069 in the accompanying worksheets.
8. We agreed the population percentage change and assessed valuations to documentation from Placer and Nevada County.

We were not engaged to, and did not conduct an examination, the objective of which would be the expression of an opinion, on the specified elements, accounts, or items. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the information and use of management and the Board of Truckee Tahoe Airport District and is not intended to be and should not be used by anyone other than the specified party.
