

Item 2. Community Benefit Policy Review – Workshop Follow Up

Community Benefit Policy (PI311)

I plan to have a redline draft revision to PI311 for the July board meeting. This will include a transition plan from the current narrow approach of a limited giving levels and programs to a more concentrated approach to programs that benefit the entire community (i.e., Wildfire Mitigation) along with the existing in-kind giving taking place. Of course, we will continue to review in-kind giving to address expiring agreements and opportunities to address untouched agreements / arrangements or activities without agreements. The policy update will not address funding levels, but outline policy methodology to address community giving. The funding level will be addressed in the annual budget process.
