

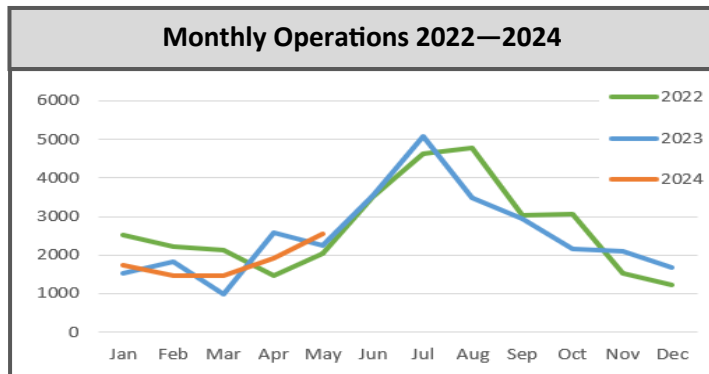
Aviation & Community Services Report

June, 2024

Director of Aviation

Hangar repairs, inspections, and revitalization have been a focus as we enter the construction season. Our largest hangar tenant displacement will be late July to August timeframe with approximately 20 tenants impacted; overall there are about 65 tenants impacted over the summer. Hangar inspections have gone well so far with no major issues and general support from hangar tenants. Fly Safe events continue to be well attended, and to date we've had 265 pilots attend a Fly Safe seminar with over 500 hours of instruction provided.

Operations



Good weather on Memorial Day closed out a higher than average month of May for aircraft activity. Glider operations returned with a soft opening towards the end of May.

Fly Safe

Local pilots are beginning to complete the Fly Safe program for 2024 with several hangar tenants submitting FAA Wings Phase certificates, to include our first non-hangar pilot. Two airshow performers gave a talk on operations risk management for the June Fly Safe Pilot Safety Seminar. In July we'll have our first flight clinic and August will be a Runway Safety Action Team (RSAT) meeting.

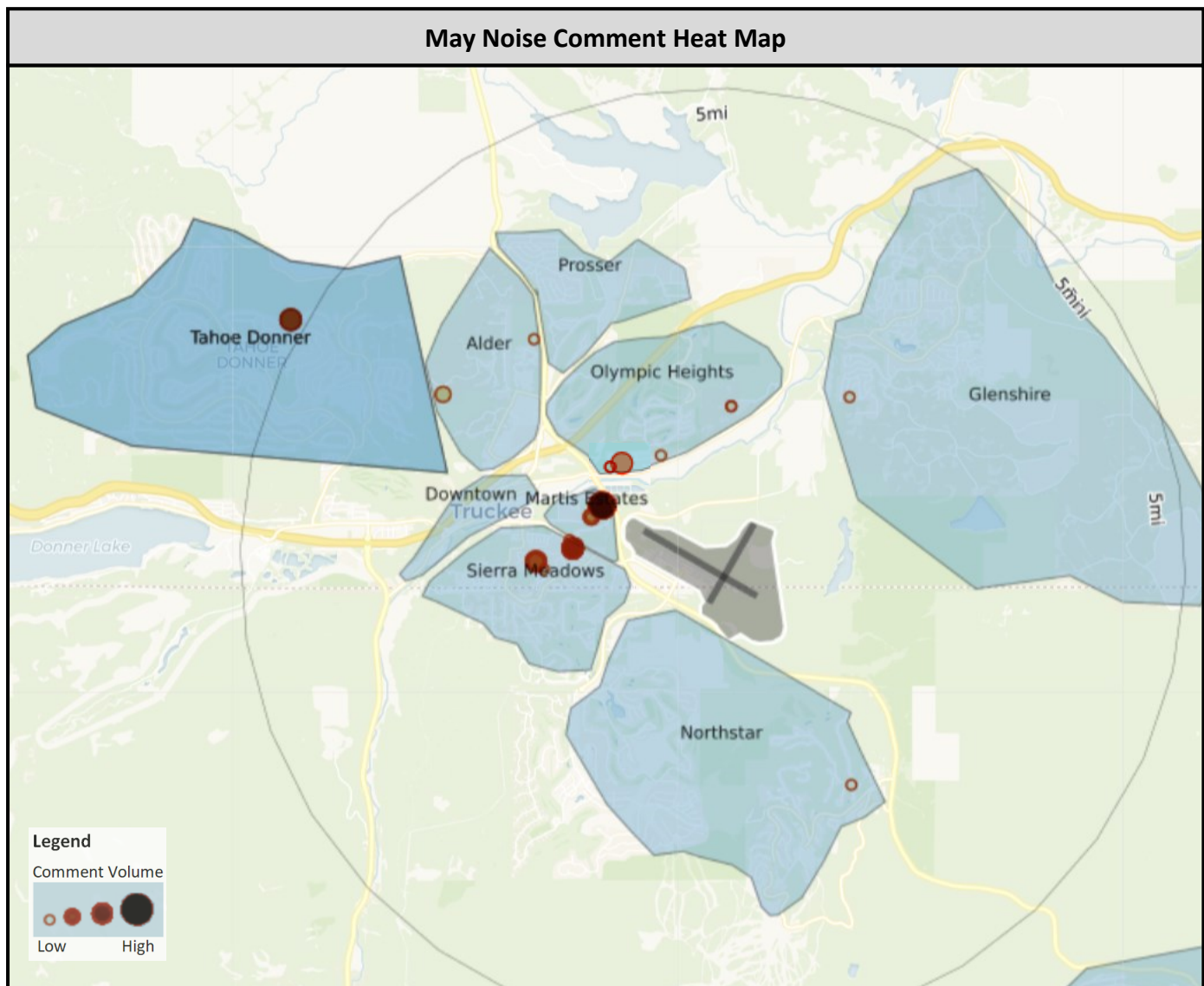

Property Management

Construction/repair work is beginning in earnest in the coming weeks. The first couple or rows of hangars have been cleared in anticipation of this and tenants shifted around to accommodate both the repair work and revitalization which will start in July. Hangar inspections will be finalized with by the end of the month (one T-hangar row and three Exec rows remain). Overall the trends indicate that 60-65% of hangars meet all inspection criteria. Approximately 20% have minor/easily correctable items to follow-up on. Five hangars thus far have been issued corrective action letters to meet the new inspection standards.
