# 1. Truckee Tahoe Workforce Housing Joint Powers Authority (TTWHA) Update – Lauren Tapia

Workforce Housing Agency The Board of Directors met on July 17, 2024, from 8:30 AM -10:30 AM. The Board approved a Service Contract with Sierra Business Council for Public Affair Services to advance public policy at the state and federal legislative and state administrative agency level to increase housing production that benefits the unique needs of the North Lake Tahoe, Truckee, and Eastern Nevada County communities. This meets one of TTWHA's strategic planning goals to "increase state funding for workforce housing". This is a one-year agreement with options to extend to a multi-year agreement as advocacy on this topic is needed for the long term. The Board reviewed a Master Lease Pilot Program Proposal from Industrial Way Sage Apartments which is a newly developed 9-unit apartment complex located at 10969 Industrial Way within the Pioneer Center. Over the past several weeks TTWHA has generated enough interest while collaborating with Truckee Tahoe Homes to successfully fill seven (7) of the nine (9) apartments, achieving approximately 78% occupancy in the complex. The units are being occupied by both TTWHA member agency employees and the general public that work within TTUSD boundaries. The proposed 5-year Master Lease Agreement between TTWHA and Truckee Industrial Way Partners, LLC will ensure rents will remain the same for the first three years, and in years four and five, rents will be adjusted based on the CPI for the preceding 12 months. The Board is in full support of the proposed Master Lease but asked staff to provide more detailed financial revenue and operating costs for the master lease agreement, as well as requesting to add extension language beyond year five. The Board expects to approve the proposed Master

Lease Agreement at the next Board meeting. The Board also approved the updated FY 2024-25 Strategic Planning priorities and Agency Work Plan, as well as the FY 2024-2025 Budget. <u>July 17</u>, 2024 Board Packet

## **Downtown River Revitalization Strategy**

The R2SC Economic Vitality Action Team (EVAT) convened on June 25, from 5:15 to 7:30 PM. During the meeting, the team developed a strategy to engage property owners on West River Street in collaboration with the contracted urban economist. This approach leverages the personal relationships R2SC committee members have with the property owners and aims to elicit their interests through targeted dialogue. The outreach has resulted in feedback from 9 of 32 key property/business owners so far.

The R2SC Steering Committee held a very productive meeting on July 15, from 5:15 to 7:30 PM. There committee was broken into 3 working groups for the evening and discussed future possibilities of West River Steet. The 3 groups all agreed separately that the current road configuration is not conducive to the vision of the corridor, which is the first time the group arrived at this consensus.
