- Updates from Steve
 - Climate Bond passed in the legislature was proposed to be 16 Billion, passed at 10 Billion
 - Will be on the November ballot as Proposition 4 funds a variety of climate-related work
 - Now an estimated 6.7 million units of housing require AC that didn't 20 years ago
 - Will have a full campaign for the climate bond with SBC
 - SBC is 30 years old this year!
 - Having a 30th-anniversary party at Gravity House on September 13th in the

evening

- Updates from Brittney
 - o Truckee Tahoe Building Decarbonization Pilot Program is fully operational now
 - Online workforce training videos are up and available for participants
 - In-person training July 17th
 - Free coaching service is available to homeowners and commercial building owners to assist with switching to heat pumps for space heating & cooling and water heating. Services include helping find a qualified contractor, navigating funding opportunities, and supporting completing a home assessment.
 - Dark Sky Outdoor Lighting Program
 - Been able to help retrofit 57 lighting fixtures so far
 - Lots of positive feedback
 - An additional bonus of \$20 per fixture for fixtures with motion sensors

Member Presentations

Sugar Bowl - Katya Christian Presenting

- The first role was specifically for sustainability at Sugar Bowl
 - More long-term project planning
- When she started, Sugarbowl didn't have a sustainability strategy
 - Pillars of Sustainability
 - Engagement
 - Collaboration with the community (like coming to CTA events)
 - Sharing sustainability efforts with people coming to the resort
 - Waste Reduction managing food waste from food and beverage
 - Want to become landfill waste-free
 - Forest Health a big portion of her time
 - Privately owns hundreds of acres of land
 - Doing fuel reduction work to make forests more healthy and prevent wildfires from coming in
 - Energy & Emissions

- Currently working on tracking energy and emissions haven't started working on cutting down on them
- Starting with low-hanging fruit clean energy alternatives
- Greenhouse Gas Emissions measuring with NSAA Climate Challenge framework
 - o Scope 1: Lots of propane, not on natural gas
 - Trying to move away from this
 - Scope 2: Trying to figure out the emissions factor from Pioneer Community Energy
 - Scope 3: Mostly solid waste right now
- Graph of emissions from 2020-2024
 - Two years were lower because of COVID
 - The 2022-2023 winter had very high emissions due to the huge amount of snow and the long winter
 - o Lower in 2023-2024
- Sustainability Projects
 - LED Lights
 - Moving to all LED lights also saves money for the resort
 - Seeing ¾ electricity reduction from installing LED did through On Bill Financing through PG&E
 - Fuels Reduction Projects
 - Over half funded by local grants
 - Doing fuels reduction on 291 acres
 - Waste Reduction
 - Switched to reusable dishware at the Judah Lodge
 - Want to make Judah Lodge fully reusable
 - Difficult to do this in the other two lodges because there isn't space in the kitchen to do more dishes
 - Composing been a challenge
 - Currently food waste goes to landfill
 - Need to do on-site composting cause it is too remote to take compost somewhere else
 - Transportation
 - No public transportation to Donner Summit TART doesn't go there
 - Wants to make public transport from Truckee to Donner Summit
 - Revived Donner Summit shuttle which goes around Donner Summit
 - Woody Biomass Energy
 - Received a grant to start this project
 - Helps solve fuel load issues and provides more renewable energy
- Challenges being in a place controlled by weather
 - Makes it harder to do sustainability work because often don't have the funds to pay for it themselves (weather changes cost a lot of money)
 - Need grant money to get things done faster otherwise, it happens slowly as the resort has the money

Palisades Tahoe - Erik Miller Presenting

- Palisades now owned by Altera for the past 6 years
- Altera Forward Stance Commitment has three targets for sustainability to meet by 2030

- Reduce Carbon Emissions by over 50%
- Transition to 100% renewable
- Become carbon neutral
- At Palisades Tahoe 3 people in the department but also working on safety
 - Has a working group that helps with sustainability efforts
- Energy reduction and efficiency
 - Extensive energy audited and GHGis
 - o Audited all existing buildings through Altera this past year
 - Lots of low-hanging fruit that haven't been done yet
 - Sustainability is key to saving Palisades money
- Renewable Diesel Transition
 - o Now using hydrotreated vegetable oil-derived diesel chemically identical to diesel
 - Emissions reductions come from the lifecycle of the diesel
 - Up to 75% life cycle GHG emissions vs fossil diesel
 - Very difficult to change diesel can only do it in the summer
- Parking and Transportation
 - Wasn't designed as a sustainability initiative but traffic getting to Palisades has lots of environmental impacts
 - 10x increase in Park and Ride bus transport system after parking reservation system started
 - Likely limited VMT by 300,000 with Park and Ride system
 - o Employee Carpool incentives were available, reduced cars going to Palisades as well
 - EV charging stations as Palisades adding 8 more chargers to Palisades
- Electrification
 - Planning to convert snowmobiles to EV need to expand charging before can do this
 - On-road fleet ordered 2 EVs
 - Exploring on-site energy generation options
 - o Liberty is at under 50% renewable energy at the moment but working to expand this
 - Palisades is currently on Liberty
- Waste Reduction and Diversion
 - First ski resort to eliminate plastic water bottles
 - Shuttle down food waste from mountain
 - Looking into on-site composters
 - Difficult to get on the mountain
 - o EcoChit recyclable receipt paper moving toward Alterra-wide adoption
 - Recycling cooking oil
 - Composting
- Advocacy and Collaboration
 - Paid volunteer opportunities for Palisades employers to volunteer at local environmental events
 - o Tahoe Earth Day at Palisades
 - Carbon Neutral and Waste Neutral Event pledge events at Palisades need to be sustainable
- Major challenges
 - o Reliant on Liberty using lots of fossil fuels still
 - o Scope 3 emissions difficult to measure and quite significant

- Altera is giving up on tracking this because it's so difficult to track
- Travel to resorts + vendors
- Cost Return on Investment
- Technology limitations more because of location

Vail Resorts/Northstar - Ryan Groat Presenting

- Vail Resorts sustainability program the goal of 0 net emissions by 2030
 - o 100% renewable electricity in North American resorts
 - o 15% more energy efficiency
- Installing solar and wind in some places
- Northstar Specific:
 - Carpooling has reduced emissions
 - EV charging stations
 - Energy reduction projects
 - Mostly updated to LEDs
 - High-efficiency snow guns
 - Programmable thermostats
 - Tracking emissions from snowcat fleet reducing idling
 - Energy management program to track emissions
 - Closing checklist making sure to close things in the summer when facilities aren't in use
 - GHGi collected and reported yearly
 - Supporting biomass project
- Waste Reduction Initiatives
 - Employee waste sorting not done by guests
 - Working on upgrading dish machines to be able to wash more dishes then can use reusable dishware
 - Hard-to-recycle programs
 - Chairs made from recycled material
- Challenges
 - o The ski industry is dynamic and a difficult condition
 - Scale having so many resorts
 - Trying to scale up projects as acquire more resorts
