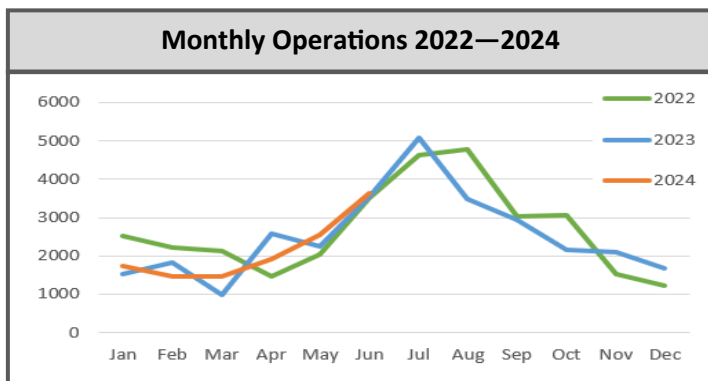

## Director of Aviation

June and July operations have been quite typical for the summer season. Hangar tenants shuffles to accommodate repairs and revitalization have so far been successful, but the heaviest lift remains in front of us.

Fly Safe and Fly Quiet have be proceeding nicely and next month we are sponsoring our first Fly Safe flight clinic with Mt Lion Aviation. This course is a beta course developed by Cirrus and Mt Lion is the first Cirrus Training Center to offer it. "Aviation News Talk Radio" has contacted KTRK about doing a podcast to discuss our Fly Safe program, this will likely be recorded in early August.

## Operations



Fairly average month of June with a good turnout for the airshow. Glider operations have declined in recent years. Q2 Operations down 3.5% from Q2 2023. Heavy jets increased from 26 to 56 this June to last.

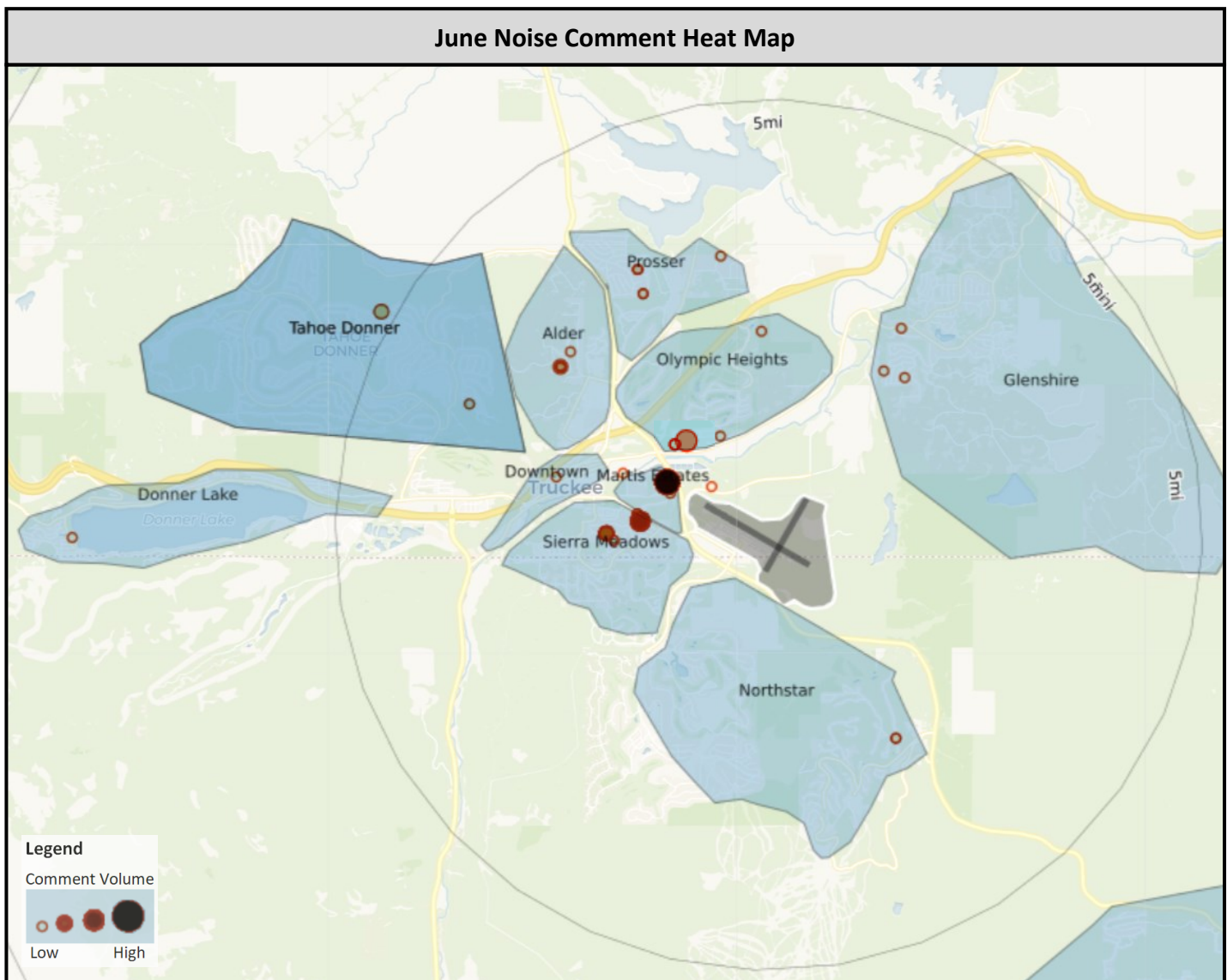

## Property Management

Construction/repair work will be ramping up significantly over the coming weeks with a major focus on the Hotel Row. Shuffling and displacement of tenants to accommodate the work continues. The initial 8 hangars for revitalization are complete. There is a lot of interest in the wait list with its anticipated re-opening in the

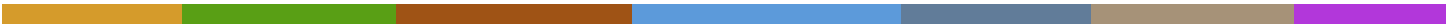
