Downtown River Revitalization Strategy

An R2SC Community Economic Vitality Action Team (CEVAT) 'Interview Committee' interviewed all eight applicants to the Town's RFI on being a Catalyst Project in the river corridor in early Jan

'25. The CEVAT then met on Jan 17 and recommended 3 projects to move forward to the Town Council on Jan 28 for the Council's approval. The three recommended sites are on the East, Central, and West River corridor and represent the largest capture of Town goals for river revitalization. The three recommended catalyst projects also represent an opportunity for a short, medium, and longer-term execution timeline: ideally all within 5-years. The CEVAT is also recommending some limited continued engagement with the five projects not selected in order to promote change in the corridor and offer learning opportunities for the Town.
