Thank you for this letter and feedback to our board for their consideration in our budget process, I'll certainly pass this along.

As additional background and information, the Airport District has adopted a new [Strategic Plan](#) this past year prioritizing four core focus areas. The largest area for community impact has been our work with the many fire districts to [reduce the fuel loads](#) to help reduce the risk of catastrophic wildfire impact to our community. While the Airport District has limited fiscal resources beyond those required to support our core aviation mission, we have prioritized investment in areas that have the most benefit to the entire Airport District. This year the Airport District has prioritized working across the District boundaries with \$2Million in funding for projects as detailed in the below graphic.
