Downtown River Revitalization Strategy

The R2SC leadership presented the DRAFT R2SC to the Town Council on June 24th. The Council was impressed with the DRAFT and had some minor input. R2SC will then meet on July 8th to discuss inputs and public comments that were received. Minor changes to the DRAFT Playbook "Restore – Revive – Reimagine (R3) were made.

R2SC also discussed the future of the Steering Committee since the Playbook is the output of the original charter from the Town Council. It is likely the R2SC will transition from a standing Brown Act body to an Ad Hoc committee with similar membership. The intent would be to meet on an as-needed basis and continue work on the 3x Catalyst projects, Receiver Sites, and River Access.
