# **Downtown River Revitalization Strategy**

Representing two years of community and R2SC committee work, the draft Action Plan has been named "The R3 Playbook," which stands for *Revitalize*, *Reconnect*, and *Reimagine*. The draft plan is scheduled for the Town Council meeting on September 23 for potential adoption.

#### **CTA Vision**

The Truckee North Lake Tahoe region will be net carbon neutral by 2045 through a combination of greenhouse gas (GHG) emission reduction and sinking or storing carbon in natural lands. Carbon neutrality will improve the environment, reduce the risk of wildfire, create new opportunities for innovation and business creation, diversify our economy, improve public health, equity and safety, and meet our commitment to steward the region for the benefit of future generations.

CTA Strategic Plan update meeting is scheduled for September 25, 2025. Director Horvath and Mr. Etnyre plan to attend with representatives from the other governing partners and Sierra Business Council.
