# Item 2 - Update on Flight Tracking FAA Interrogator Agreement

Staff will update the Board on current ongoing efforts to secure long term approval to operate the FAA provided transponder interrogator. The interrogator is an essential component of the MLAT flight tracking system. Staff continues to work with industry experts retained by the District, Oakland Center, and other FAA Departments to secure ongoing approval to operate our system.

#### Item 3 – AF/D and Procedure Update – Runway numbering and weight restrictions

The District received the *Final Determination of Landing Area* approval letter from the FAA Airport District Office. While this is a big step in having our information updated, we are still waiting for a final approval from FAA Flight Procedures. They are waiting to publish the changes to synchronize with updates to the GPS approach review currently underway for Runway 20. They do not want conflicting numbers in an AF/D and procedure plates. Staff will provide more details at the meeting.

#### Item 4 - Airport Facilities Maintenance Plan Update - Structures

Staff originally proposed to approve the plan at the August Board Meeting. District Engineer Bill Quesnel has asked to postpone final approval to the September Board Meeting allowing time to modify a few provisions of the plan related to coatings, electrical work, and to include the 3 part 77 beacon towers into the plan.

## Item 5 - Alder Hill Beacon Tower Access Agreement

Staff will meet with a representative of the HOA before the Board Meeting and will provide an update on progress regarding the access agreement.

#### Item 6 – Aviation Safety Initiatives - Update

The new density altitude signs are installed and working. Staff and ACAT are currently working on a study to review the feasibility of enhanced Unicom services to pilots, (traffic advisories, weather, etc.). Staff will provide a brief update on current projects including upcoming aviation
