Item 1 – Aviation Exhibit at the Kid Zone

Take Flight Tahoe is now open at the Kid Zone Museum in Truckee. The Grand Opening was Friday May 17th. The exhibit will be in place for the next 24 months.

Item 5 - Aviation Safety Initiatives Progress Report

The new density altitude signs are installed and working at the run-up areas of Runways 2, 20, and 29. We also have a sign at the intersection of 2/20 and 11/29. Staff is working with the vendor to have the last sign installed at the self-serve island. Additional safety signage is in the works for the ramp area, reminding pilots of important considerations such as wildlife, wind shear, runway incursions, etc.

Item 6 – Runway Obstruction Removal

Staff anticipates commencement of the runway obstruction project within the next 45 days. Mr. Stoner is working with our forester and a biologist to assure the proper permitting. We have been in contact with the Town of Truckee on the project which will remove approximately 300 trees around the touch down area of runway 11 and 20.
