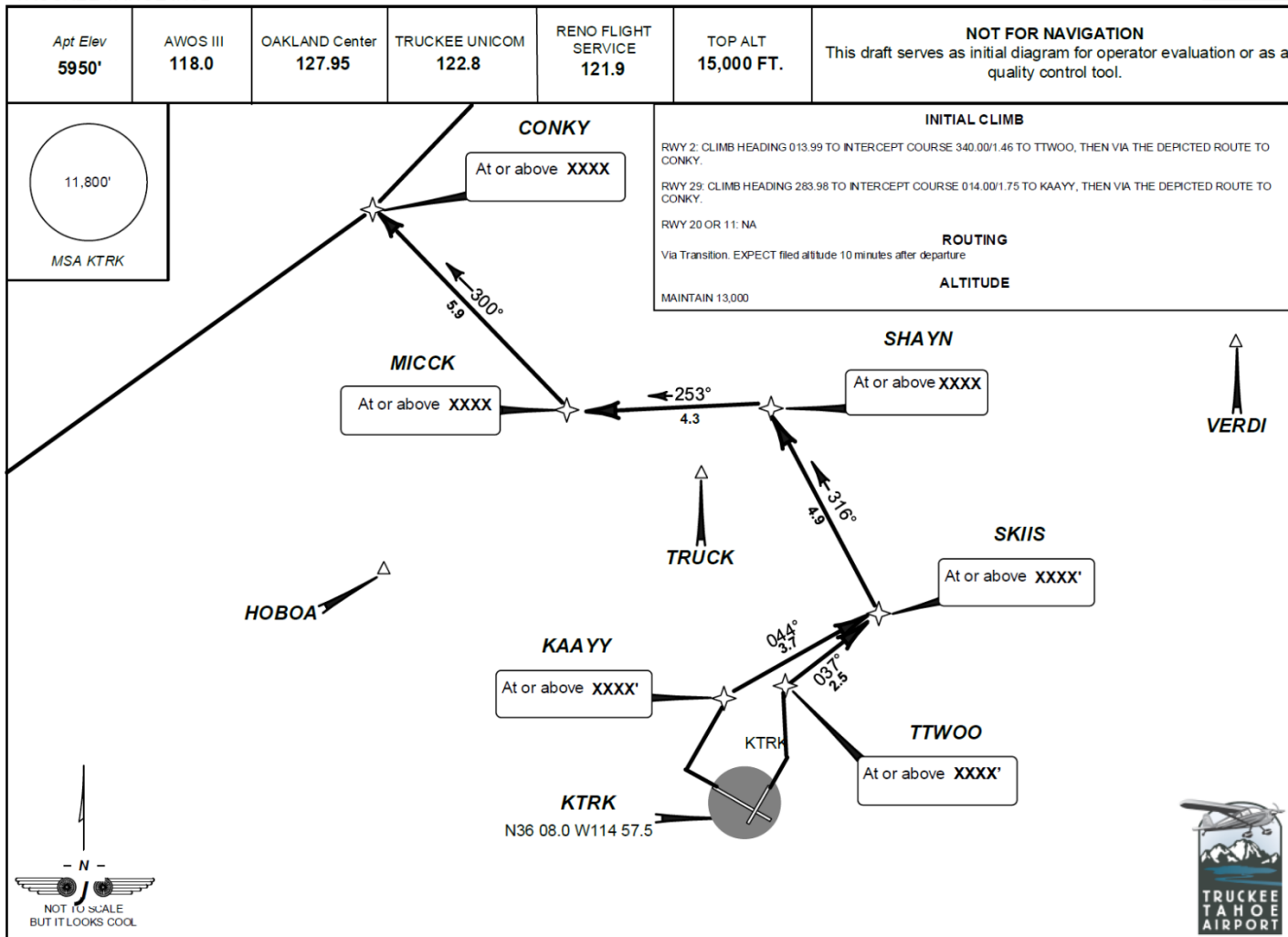

Tom & Laurel Lippert / Videography of noise abatement departures and arrivals

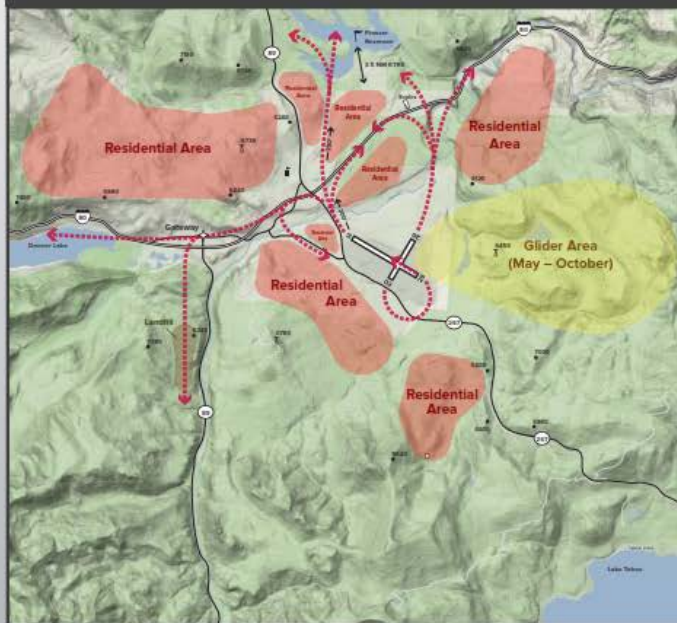
- Development of video content over the next 60 days

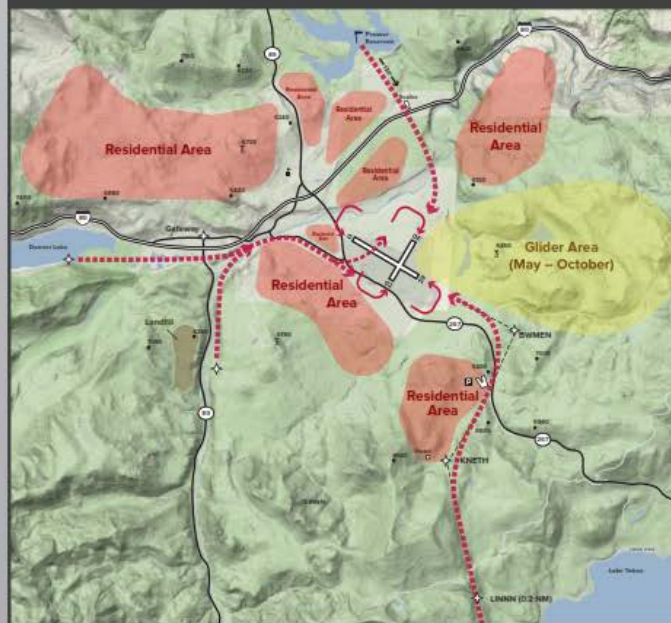

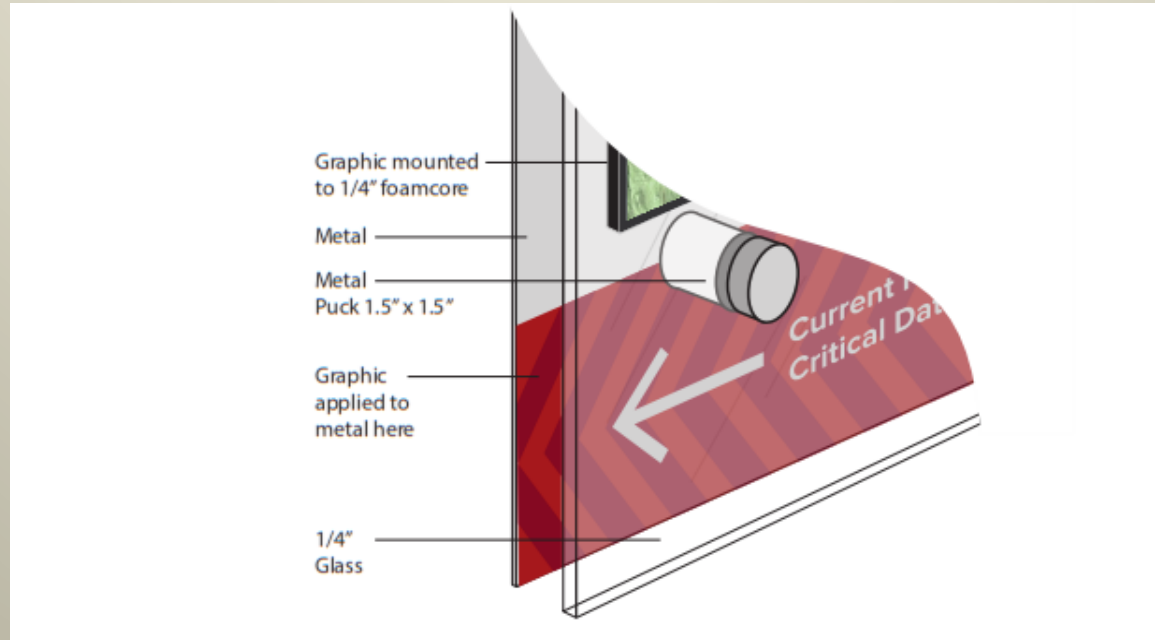
