The Truckee Tahoe Airport District's Aviation and Community Services Department seeks an individual for a full-time, seasonal NOISE ANNOYANCE TECHNICIAN.

A successful candidate will have excellent customer service, work ethic, willingness to cooperate with teammates, the ability to exercise initiative, and the ability to perform all work safely. This is an entry-level position. Experience in General Aviation airport operations and aviation communications is a plus. This position places an emphasis on receiving, researching, and processing noise complaints from District residents, which requires an exceptional external communication and customer service skillset.

Applicants must have a valid driver's license with no uninsurable convictions. While performing the duties of this job, the employee is required to stand, sit, demonstrate manual dexterity, and lift objects up to 10 - 40 lbs.

This position will work eight (8) hours a day, Monday - Friday but will transition to a Sunday–Thursday work week after 4-6 weeks of employment.
