



AVIATION:

KTRK serves private and charter aircraft but offers no scheduled commercial flights





The FAA is the sole authority over aircraft in flight. Although it is legal to fly at safe altitudes in all areas within the Truckee North Tahoe region, we continually encourage aircraft to fly over roadways to reduce annoyance.

When our community is busy with holiday travel and visitation, the Airport, as well as other transportation elements such as Interstate 80, is also busy. These peak periods affect our entire community and the Airport works seven days per week to reduce impact from aircraft overflight, particularly during peak holiday periods.

- ✈ We develop and promote noise abatement maneuvers and procedures.
- ✈ We enhance surveillance to monitor aircraft.
- ✈ We fund a control tower to safely handle air traffic.
- ✈ We make outreach to pilots before they arrive, while they are here, and after they depart.
- ✈ We incentivize aircraft operators to be community friendly and safe.

THE PROGRAM is designed to inform itinerant, local, and student pilots of Truckee's unique aeronautical ecosystem. The program goal is to enhance the knowledge of Truckee's local airspace and the surrounding area to ensure proficiency with prescribed procedures.

The fleet mix or the types of aircraft using the Airport has changed significantly over the past five years. Truckee Tahoe Airport District and national trends show traffic is directly tied to the economy. As the economy improves, especially in regions Truckee/Tahoe is tied to, such as the Bay Area, air traffic increases.

Occasionally pilots are unable to use the prescribed Fly Quiet procedures due to safety, weather, or terrain. If a flight is non-compliant with Fly Quiet procedures that doesn't mean the pilot is doing something against the law. Aircraft will be maneuvering for landing and flying low when they arrive and depart. This is normal and expected.

The District tracks comments and reports them to the Board of Directors monthly, quarterly, and annually.

All comments, research and actions are recorded and summarized for the Board of Directors. This summary information is placed on the website for public review.




Safety is always the number one priority for Truckee Tahoe Airport!

AIRCRAFT OPERATIONS AREA



- LEGEND:**
- County Boundary Line
 - Airport Influence Area. Within the red lined area it is typical to see and hear aircraft as they arrive and depart.
 - Takeoff and Landing Maneuvering Area. Within the blue area it is typical to see aircraft maneuvering for arrival and departure. In this area aircraft are making steep turns, climbing, descending, flying low under full power or low power.

Mountainous Terrain. Within the red shaded area is mountainous terrain which is not always suitable for departure climb out. Some capable aircraft may use this area for approach and departure.

Note: Aircraft are encouraged to fly over the highway areas while arriving and departing.
