Fees for aircraft not intending to remain overnight that recover operating costs associated with servicing transient crews and passengers, and allocated air- and landside costs when no landing fee is charged. The fee may apply to airplanes greater than 5,500 lbs. (helicopters greater than 3,000 lbs.) maximum certificated take-off weight (MTOW) or maximum certificated gross weight (MCGW), whichever is available. The transient use fee will be charged for each arrival. Overnight aircraft parking will be charged at the appropriate daily tiedown rate. This fee may be waived with purchase of designated amounts of fuel. General Manager shall set transient use fees. Monthly, Semi Annual, or Annual TU Fee Rates are not eligible to daily operators (defined as min. 1 visit per day over 7 day period) except through a Commercial Operating Permit and/or Fly Quiet Signatory Agreement.</p>
