The base goal projection after weighting is as follows:

• Total Weighted DBE Availability: \$922,040

Dividing the weighted DBE totals by the total estimate for all trades gives a base DBE availability figure for the projects anticipated during the goal-setting period. This figure is expressed as a percentage and serves as the basis for the three-year overall goal.

Base of DBE Goal: 15.3%

Past History Participation

One piece of data used to determine the adjustment to the base figure was the median of historical DBE accomplishments, as follows:

Arranging this historical data from low to high (1.02%, 4.74%, 7.63%), the median is 4.7%.

Step 1 Base averaged with historical median: (15.3% + 4.7%) / 2 = 10.0%

To arrive at an overall goal, the Step 1 base figure was added to the Step 2 adjustment figure and the total was averaged, arriving at an overall goal of **10.0%**. Truckee Tahoe Airport District believes this adjusted goal accurately reflects DBE participation that can be achieved for the types of work being awarded during this three-year goal period (FY 2022-24).

Breakout of Estimated "Race and Gender Neutral" (RN) and "Race and Gender Conscious" (RC) Participation

TTAD will meet the maximum feasible portion of the overall goal by using race neutral means of facilitating DBE participation. This can be done by:

- 1. Arranging solicitations, times for the presentation of bids, quantities, specifications, and delivery schedules in ways that facilitates DBE, and other small businesses, participation;
- 2. Providing technical assistance and other services for bidding organizations
- 3. Ensuring distribution of DBE directory, through print and electronic means, to the widest feasible universe of potential prime contractors;
- 4. Encouraging minority or women owned companies that already do business with TTAD but are not DBE certified to get certified.

TTAD estimates that in meeting the established overall goal of 10.0%, it will obtain 10.0% from race neutral participation and 0.0% through race conscious measures.

TTAD will attempt to obtain DBE participation organically, that is, without race concious measures. In all Requests For Proposals (RFP) TTAD publishes for FAA-funded projects, the RFP's will mention the overall goal and will encourage Prime Contractors to use DBE's as much as possible. Throughout the three-year period, however, if TTAD is not meeting their 10% goal by race neutral measures, TTAD will considder adding contract goals to projects that would help reach the overall three year goal of 10%.

Consultation

In establishing the overall goal, Truckee Tahoe Airport District (TTAD) provided for consultation and publication. This involved announcing the three-year goal on TTAD's website and multiple bulletin boards in the airport terminal building and providing 30 days for public comment. Additionally a Zoom meeting was scheduled for Monday, December 6, 2021 for interested stakeholders to discuss the goal with airport directors prior to submitting the goal to the Federal Aviation Administration.

During the 30 day period no comments were received and there were no participants in the December 6, 2021 Zoom meeting.

If the proposed goal changes following review by Federal Aviation Administration, the revised goal will be posted on TTAD's official website.

Notwithstanding paragraph (f)(4) of §26.45, TTAD's proposed goals will not be implemented until this requirement has been met.
